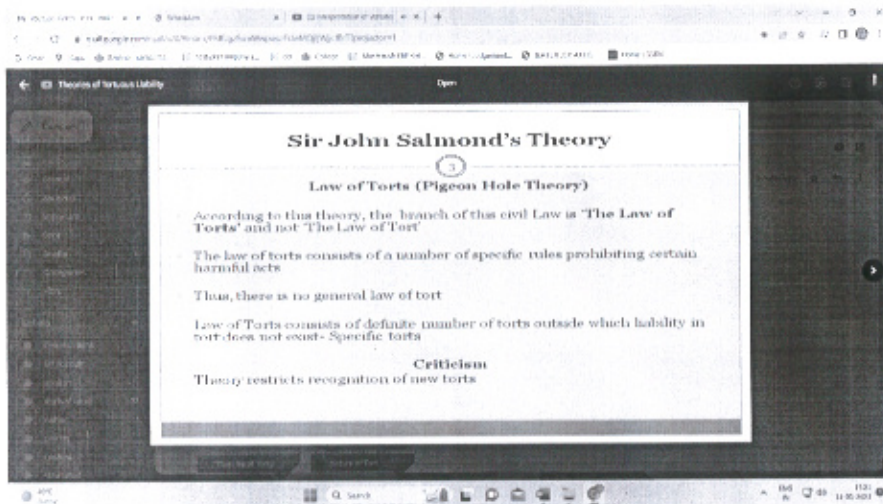
**Basis of issues**

- Court may frame issue from the following materials.
  - Allegation on oath by party or its agent or pleaders.
  - Allegations made in pleading.
  - Allegations in answers to interrogatories delivered in the suit.
  - Content of document produced by either parties.
- Court may before framing of the issue, may examine any person or inspect any document.
- It may adjourn the framing of such issue till 7 days and may compel attendance of any person or production of document by summons.

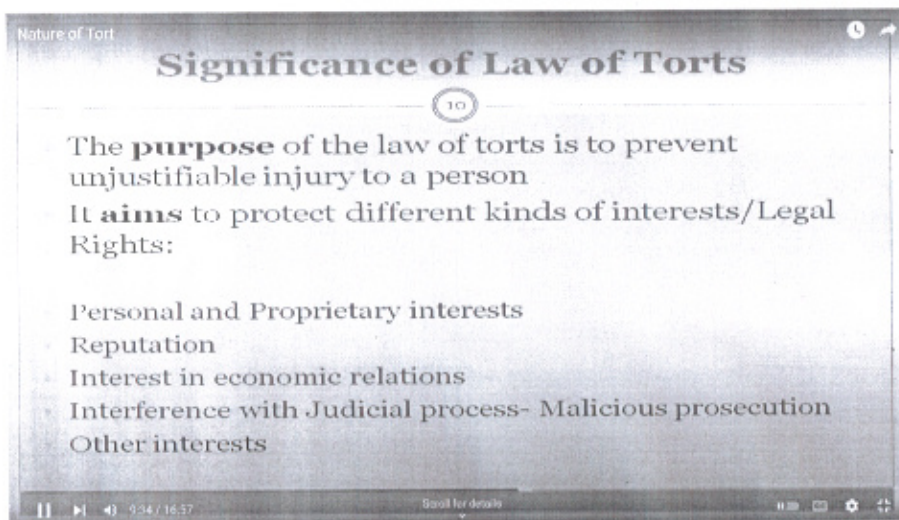
