Mechanism to deal with internal examination related grievances.

For the internal examinations, the students are given detailed instructions regarding the conduct timing syllabus, and the same is displayed on website as well as WhatsApp groups.

Further in case of any grievance especially during the covid times when the students could not give the examination due to internet failure or other reasons the institution had made special efforts to take exams again. Hence no student is deprived of the examination facility.

In case of any grievances the student is instructed to apply to the Chief examination officer. The grievances are immediately acted on and remedied. The institution has constituted an Examination Committee. The secretary of the said committee is Chief examination officer (ex officio). In case of any Major or policy decisions a meeting is convened, and appropriate decisions are taken and implemented. The decisions are conveyed to aggrieved party, if any.

To ensure on efficient examinations the proctoring is enabled to avoid cheating in exams. further the exams are taken based on MCQ questions, and the result are promptly displayed and communicated through mobiles to concerned students.

The results are also displayed on web sites. In case of grievance, relating to marking especially by human mistakes the attendance sheets are scrutinized to remove the defects.

In case of human errors by concerned teachers in uploading the internal marks letters are promptly given to examination department at university to correct the same.

Before and after covid internal examinations are conducted, based on assignments and the concerned subject teachers promptly assessed and mark them and intimated the marks to respective students. in case of any defect in assessment the students are given choice of calling for photocopy of the answer sheets and further re-evaluation and verification of marks can be requested by students in case of any difficulty the subject teacher gives guidance to the concerned students for proper answer and understanding

In case the student is aggrieved by the assessment he can make an appeal to principal madam. The Principal directs the student to either COE or refers to Committee.
