The gamut of advocacy includes the skills of handling your client, giving him the right advice, researching the areas of law relevant to the case you are preparing for, drafting skills, making oral submissions, cross-examining witnesses in criminal trials and being able to put forward a strong and persuasive case.

ABOUT COLLEGE

The course is designed in such a manner so as to make the students well versed in important aspects of advocacy and drafting skill. The contents of this certificate course include the study of key principles of Civil and Criminal Law, Law of Contract, appreciation of evidence and arguments before the courts, registration process, drafting skills, counseling skills etc.

Experienced personalities from the field of law such as senior lawyers and retired judges, having expertise in the relevant course content, will be invited to deliver lectures.

A student cannot appear for the examination unless he/she has maintained 75% attendance during the teaching period of the course. The students will be assessed for 100 marks (50 marks for written examination and 50 marks for project and assignments). On completion of the course successfully, the student will get a certificate with a grade on it.



MODE OF CONDUCT

This certificate course shall be conducted through online platform Microsoft Teams.

WHO MAY REGISTER

Considering the nature and scope of the course-content, only the students of LL.B II, LL.B III, B.A.LL.B IV, B.A.LL.B V and LL.M are eligible for undergoing this course.

Rules of the Course

- The students of LL.B / B.A.LL.B / LL.M are eligible for this course.
- This course carries two credits.
- Each credit will be equivalent to 16 clock hours of teaching.
- A student cannot appear for the examination unless he/she has maintained 75% attendance during the teaching period of the course.
- The students will be assessed for 50 marks.
- Assessment process shall consist of the following:

1. Project/Assignment (20 Marks)

Project Writing / Report Writing /Field Visit / Essay Writing

2. Written Examination (30 Marks)

15 MCQ type questions for 1 Mark each

3 Short answer questions for 5 Marks each

- To pass the course, the student has to obtain forty percent marks in the combined form of internal assessment and the final examination.
- If a student misses an internal assessment examination, he/she will have a second chance with the permission of the teacher concerned. Such a second chance shall not be the right of the student: it will be the discretion of the teacher concerned to give or not to give second chance to a student to appear for internal assessment.
- Students who have failed in the examination may reappear for the exam in the subsequent period.
- On completion of the course successfully, the students will get a certificate with a grade on it.
