### 1. Interpersonal Skill - "Online Client Counseling Competition, 2020"

The first evaluation criteria for practical work under the subject of Skill Development-I was Interpersonal Skill. Under this criteria LL.M department has organized an 'Online Client Counselling Competition' for 10 Marks. The basic aim of this competition was to enhance the fundamental skills among the students such as the ability to take an interview and ability to counsel. It has promoted greater knowledge and interest among the students about the practical application of the laws. On 19/10/2020 faculty in charge has taken the orientation session for the online client counselling competition wherein she has clarified all the rules of the competition. 48 students of LL.M – II second year was divided into 24 teams. Each team shall comprise of two students consisting of an advocate and client. The competition was divided into two rounds- preliminary and final round. The problems in the preliminary round were selected from the subject of Consumer Law. The problem for the final round was selected from Law, Science and



Technology. The problem of preliminary round was given to the clients before one day of the competition and of the final round was given 30 minutes prior to the round.

Preliminary round was conducted before three separate Chambers having 8 teams and from each chamber one team was selected for the final round. The faculties of LL.M department were presided as the judges of the preliminary round. The advocates were assessed on different criterion namely establishing work atmosphere, appearance of the advocate, eliciting problem of the client, satisfaction of the client's goal, expectations and needs, suggesting an alternatives in conclusion of the consultation, post consultation session with the judges etc. The clients were assessed on the narration of facts to the advocate.

### **Preliminary Round**

The competition began with opening address of the concern faculty were in she took the opportunity to extend a warm welcome to all the participants of the competition. First problem was related to the Loan Recovery by Bank. This problem was discussed by three teams from Chamber No.1 - After greetings by the counsel the client has explained about himself and his issues. He told that he has taken the loan from the bank and because of his genuine reasons he was not able to pay the bank instalments. He also clarified that how the agents of the bank humiliated him and take the possession of the security forcefully.

After extracting relevant information from the client counsel suggested about the criminal remedies as well as remedy before the consumer court. In post consultation session concern judge inquired about the advice given by the counsel and also asked about the extra judicial remedies. The second problem was related to the Renewal of Health Insurance Policy. This problem was discussed by remaining three teams from Chamber No.1 — Client told that his parents have taken

health insurance policy from Insurance Company and after its renewal company has delivered only a soft copy of the policy to his parents. He said that when asked for the third renewal company replied that the policy was already cancelled by the company.

The judge has asked about the essentials of the Consumer Protection Act. She questioned the counsel if they were going before the civil court then how will they file a case. 


### Final Round-

much. Professor in charge Dr. Ragini Jangam worked as the coordinator of this activity under the guidance of Dr. Shubhada Gholap Principal of our college.




Figure 9 - Feedback of the Activity
