The Republic of Hindikaala is located in the South Asian Region of Asia. It is one of the ancient nations in the world. Till 1947, Republic of Hindikaala was a British colony for about 150 years. It achieved independence in 1947. Now the Republic of Hindikaalais a democratic country with a written Constitution which came into force in 1950. It has 29 States and 7 Union Territories. The Constitution has adopted Parliamentary system wherein President is the executive head of the government. The majority of the population of the country belongs to Hindu religion. Buddhism, Christianity, Islam, Jainism and Sikhism are the other major religions followed by the people of Republic of Hindikaala. The Republic of Hindikaala is characterized by a diversity of religious beliefs and practices, dressing, cultural outlook, food-habits etc. Some religion like Jainism strictly follow the principle of non-violence and therefore stressed upon vegetarian food habit. This is not so in case of other religions. Under Hindu religion some are vegetarians and some are non-vegetarians. Throughout the Republic of Hindikaala's history, religion has been an important part of the country's culture. The history of Republic of Hindikaala has witnessed some prominent instances of religious disharmony amongst various religious groups.

The Constitution of Republic of Hindikaala declares various rights as fundamental rights. Some of the fundamental rights are the right to freedom of religion, freedom to carry on any trade, profession and business, right to life and personal liberty etc. The fundamental rights are mostly enforceable against the 'State'. The concept of 'State'is defined by the Constitution ofRepublic of Hindikaala. The Constitution also incorporates some features of secularism. The Supreme Court of Republic of Hindikaala, in its few landmark judgments has expanded the



- It sought to prohibit the transport (from the State of Mahakaala to another state), the export, as well as purchase, sale and disposal of cows, bulls and bullocks for the purpose of slaughter.
- It sought to prohibit the possession of the flesh of the cow, bull or bullock slaughtered in contravention of the provisions of the Act.
- It also criminalizes the possession of beef per se, whether or not this was obtained through lawful slaughter from another state.
- The amendment sought to put the burden on the accused that he/she was not in contravention of provisions of the Act.
- 6. The amendment also stipulated punishment for the contravention of the Act.

The Amendment Act, 1995 received the assent of the President in 2015 and came into force immediately. Meanwhile there was a political turmoil throughout the Republic of Hindikaala. Various religious organizations started large scale mobilization against slaughter of cows. Few individuals were attacked on the accusation that they stored cow-flesh in their home. It created the tension between those who were beef-eater and those who were not. More particularly, a minority community 'X' was affected drastically as beef eating was their common food habit. Moreover, beef was less costly as compared to other non-vegetarian food. As the degree of poverty is higher in community 'X', beef eating was an easy source of protein for them. But with the new amended law by the state of Mahakaala, they were deprived of this source.

In this background, writ petitions were filled by various associations and individuals before the Hon'ble High Court of State of Mahaakala challenging the constitutional validity of the Amendment Act of 1995. Mahakaala Butchers' Association, a Registered Society is one of the petitioners working for the protection of the interest of minority community'X'.

This petition is posted for final arguments and for disposal on 20th January, 2018.

Note: 1. The participants to the competition have to frame the issues and make submissions by presuming that the Constitution of India and all other laws applicable in India are applicable in Republic of Hidikaala.

- With reference to the Act of 1978 and amendment of 1995, the participants shall refer to the Maharashtra Animal Preservation Act, 1978 along with the amendments made to it from time to time.

## MOOT COURT PROBLEM

Indoi, is one of the oldest civilizations in the world. Since its independence from the British ruling it has achieved an all-round socio-economic progress. It is a democratic Union of States having a written Constitution guaranteeing various fundamental rights. The freedom of speech and expression is one of the fundamental rights incorporated under the Constitution of Indoi.

In the last number of years, various instances have taken place wherein the citizens of Indoi have been charged with 'sedition', an offence under its criminal law. Sedition, a cognizable offence is considered as a high-value crime against the sovereignty of the Indoi. The country's official record of crimes, *Crime in Indoi* by National Crime Records Bureau reported 165 arrests on the charge of sedition in the last three years across the country.

The provision has been the issue of intense debate. Various arrests have increased the discontent against the offence of 'sedition' causing the harassment of individuals and contending the violation of freedom of speech and expression and other fundamental human rights.

- Mr. Karmik, a cartoonist took part in a public rally against corruption and in the course of it he raised banners of his cartoons criticizing and mocking the Constitution of Indoi and also the Government of Indoi. He was charged with the offence of sedition.
- Ms. Andhodhati, a noted writer and political activist while speaking from public forum, criticized the policies of the Government of Indoi and made certain "anti-Indoi" remarks in her speech for which she has been charged with sedition.
- 3. Organization named 'Human Rights Defender' conducted one seminar discussing the violation of various human rights by government agencies and alleging violations by them. In one session, the organizers also arranged for discussion with the families alleged to be the victim of violation of human rights by the government agencies. During this discussion certain remarks were made against the Government of Indoi.



Citizens' Commission on Civil Rights, a Civil Rights Organization challenged the blatant use of section and charge of the offence of sedition amounting to the violation of the various fundamental rights. The petitioner contests the constitutional validity of the offence of sedition.

This petition is posted for final arguments and disposal dated 02/02/2019.

#### Union of Chalukya

The Union of Chalukya is located in the Southern region of Asia. It is one of the ancient nations in the world. It is a democratic country with a written Constitution and having 28 states and 9 Union Territories. The history and legal system of Union of Chalukya is same as history and legal system of India.

in Union of Chalukya, as like other democratic countries of the world, has overburdened judiciary with a flood of pending cases in its Courts. Therefore, by an amendment in the Constitution of Chalukya, a system of quasi-judicial machinery in the form of tribunals was introduced to resolve administrative and other disputes. In the light of this Constitutional amendment, various tribunals were established under various legislations. These tribunals run in parallel to the courts and generally are less formal, less expensive and less time consuming.

The Chalukya Finance Bill, 2017 was introduced in the Lower House of Parliament of Chalukya as a Money Bill. This move was vehemently opposed by the opposition parties. The Chalukya Finance Act, 2017 came into effect on March 31, 2017 after it received Presidential assent. Under the Chalukya Finance Act, 2017 certain amendments were carried out to merge together the provisions regarding the structure and organization, as well as the conditions of service of tribunals.

The Chalukya Finance Act, 2017 also authorised the Government of Chalukya to notify rules regarding persons appointed to tribunals on the matters relating to terms of office and conditions of service. The Government of Chalukya notified the Chalukya Appellate Tribunal and Other Authorities (Qualifications, Experience and Other Conditions of Service of Members) Rules 2017, a delegated legislation, in furtherance of the said authority.

JANHEET, A Rgistered NGO is working for the maintenance of Rule of Law and good governance in the Union of Chalukya. The NGO approached the Supreme Court to challenge the passage of the ChalukyaFinance Act, 2017 as a Money Bill and challenging its constitutional validity on the ground that it violates the basic features of the Constitution of Chalukya.

Note: The participants to the competition have to frame the issues and make submissions by presuming that the Constitution of India and all other laws applicable in India are applicable in the Union of Chalukya.

## RULES

## Venue and Date:

Yashwantrao Chavan National Moot Court Competition (2019-2020) shall be held on Friday 24<sup>th</sup> and Saturday 25<sup>th</sup> January 2020 at A.B.M.S. Parishad's Yashwantrao Chavan Law College, Parvati, Pune - 411 009.

## 1. Eligibility:

- 1.1. All the Colleges / Institutions / Schools in India imparting legal education are welcomed to send only one team of three students to participate in the competition.
- All regular students of three years or five years law courses during the academic year 2019-2020 are eligible for the competition.
- 1.3. The organising college may have a team participating in the competition.

## 2. Team Composition:

- 2.1. Each team shall comprise of three members consisting of two mooters and one researcher.
- 2.2. The researcher will not be allowed to speak except under special cases and at the discretion of the court.
- 2.3. A code number will be given to each participating team (such as T1, T2, T3 ... etc.) as well as to the mooters (such as P1, R1, P2, R2 ... etc.) and to the researchers (such as RS1, RS2, RS3... etc.).
- 2.4. The badges containing the code number of the participants will be provided to all participants. The participants shall wear those badges during the whole competition.
- 2.5. The identity of the participant, participating team, or College / Institution / School should not be disclosed to the judges or to anyone either directly or indirectly during the conduct of the Competition.

## 3. Registration of Team:

3.1. There will be maximum 15 teams allowed to participate in the competition. The team registering and paying fees earlier will be considered for the competition. The registration for the competition shall be made by submitting the registration orm along with registration fee of Rs. 1,000/- by Demand Draft of a nationalised bank drawn in favour of Yashwantrao Chavan Law College, Pune payable at Pune to the following postal address by 11<sup>th</sup> January, 2020.

### 4. Memorials :

- 4.1. All teams must submit five copies of the Memorials on or before the 15<sup>th</sup> January, 2020. Memorials shall strictly contain following particulars:
  - The table of contents,
  - The index of authorities,
  - The statement of jurisdiction,
  - The statement of facts,
  - The statement of issues,
  - · The summary of pleadings,
  - The arguments advanced,
  - The prayer.
- 4.2. All spirally bound copies of memorials of the Petitioner must be with <u>blue colour</u> cover and for the Respondent must be with <u>red colour</u> covers.
- 4.3. The memorial should not be of more than 20 pages. The first page *i.e.* page after the cover page should provide the information as to name of the competition, name and address of the participating College / Institution / School and name and class of individual member of the team. The information as to name and address of the participating College / Institution / School and name of the participating College / Institution / School and name and address of the participating College / Institution / School and name of the participating College / Institution / School and name of member of team should not be disclosed in any manner whatsoever on any other page, including cover page, of the Memorial. Both the mooters of each team shall prepare both the sides *i.e.* petitioner and respondent.
- 4.4. The Memorial shall strictly be in the following prescribed form: Principal part:

Paper size - A4, Font type - Times New Roman,

Font size - 12, Spacing - 1.5, and Margin on all sides - 1 inch.

## Footnotes:

Font type - Times New Roman, Font size - 10, and Spacing - 1.

- The Memorial must not contain any Annexure, Photographs, Sketches, Exhibits or Affidavit, etc.
- 4.6. The participants are advised to carry extra copies of Memorials for their own use. The copies submitted to the organizers will be for the use of the organizers.

# 5. Marking Criteria for Memorials :

5.1. The memorials will be assessed by a special panel of two memorial judges. The decision of the memorial judges as to assessment of memorials shall be final.

- 5.2. The memorials for both the sides will be marked on a total of 30 marks each by two memorial judges separately. Accordingly, the Team Memorial Marks will be the aggregate of the marks given by both the memorial judges to the memorials of both the sides.
- 5.3. The allocation of 30 marks for each memorial shall be made on the basis of the following criterion:

# 6. Drawing of Lots and Orientation of Participants:

- 6.1. There shall be the reporting and registration on Friday 24<sup>th</sup> January 2020 at 09.00 am. It will be followed by inauguration of the competition. After inauguration, orientation programme of the participants will be held at 10.30 am.
- 6.2. At the time of reporting, the participants must carry with them the photo identity card duly signed by the Principal / Director of the College / Institution / School.
- 6.3. The purpose of orientation programme is to make the participants aware about the rules of the competition and to draw the lots so as to assign courts to the participant teams and also to decide which side (Petitioner or Respondent) a team member is going to present for the preliminary round before the allotted court.
- 6.4. The competition shall consist of preliminary and final rounds.
- 6.5. In a preliminary round the Petitioner and the Respondent from each team shall argue against the petitioner or the respondent of the other team as per the lots drawn.

## 7. Preliminary Round:

- 7.1. For the preliminary round, there will be three Courts established.
- 7.2. Participating team members must maintain the decorum of court and they shall follow the dress code as prescribed by the Bar Council of India under the Advocates Act, 1961.
- 7.3. Each mooter will have a maximum of 15 (12+3) minutes to present his/her oral submission. A maximum of 5 minutes can be reserved for the rejoinder/ sur-rejoinder from the allotted time of 15 minutes.
- 7.4. Three minutes before the completion of the allocated time for each mooter there will be a warning bell, and at the completion of the allotted time for each mooter there will be a final bell.
- 7.5. The decision of the Court officer as to the time structure and the right to rejoinder / surrejoinder will be final.
- 7.6. All the participating teams will have to carry with themselves any case law and authorities which they intend to refer.

- 7.7. The oral submissions for **both sides** shall be marked on a total of 100 marks each by two judges separately. Accordingly, the oral submission marks of the team will be the aggregate of the marks given by both the judges to the oral submissions of both the sides.
- 7.8. The allocation of 50 marks for each oral submission shall be made on the basis of the following criteria:

- 7.9. The decision of the judges as to assessment of oral submissions shall be final.
- 7.10. The total marks of each individual mooter shall be computed by adding marks given by both the judges in oral submissions at the preliminary round and the **best mooter prize** shall be given to the mooter with the highest total marks.
- 7.11. On completion of the preliminary round the total marks of each team shall be computed by adding the oral submissions marks of both the mooters and the memorial marks. Top team from each court shall qualify for the final round.
- 7.12. On considering the total marks of each team, if there is a tie between two or more teams within the same court, then a team having greater memorial submission marks shall be qualified for the final round.
- 7.13. If the tie again persists, all those teams shall be qualified for the final round.
- 7.14. If there is a tie between two teams within the same court, memorial marks of those teams would be considered for selecting a team for the final round.

## 8. Final Round:

- 8.1. In the final round there shall not be mismatch of the Petitioner and Respondent.
- 8.2. If a mooter at preliminary round has submitted his/her oral submissions on behalf of one party then at the final round he/she has to submit his/her oral submissions on behalf of the opposite party i.e. the petitioner of the preliminary round will be the respondent in the final round and vice-versa.
- 8.3. The other rules applicable to the preliminary round as to allocation of 50 marks, time schedule, general conduct, etc. shall be applicable *mutatis mutandis* to the final round.
- 8.4. On completion of the final round, the total marks of oral submissions of each team in the final round shall be computed and the top two teams with the highest total marks shall qualify for the prizes.
- 8.5. If there is a tie between two or all the three teams, memorial marks would be considered for deciding winner of the competition.

PRIZES: There will be four prizes: First prize Second prize Best Mooter Best Memorials (Team Prize)

: Rs. 10,000/-, Certificate and a trophy.
: Rs. 7,000/-, Certificate and a trophy.
: Rs. 3,000/-, Certificate and a trophy.
: Rs. 2,000/- and a Certificate

The certificate of participation will be given to all other participants.

### 9. BEST MOOTER

For the selection of Best Mooter Prize, marks of oral submission of the preliminary round will be counted.

## 10. Accommodation and food:

Accommodation will be suggested for the participants and no separate accommodation will be provided by the College. Food for the participants, on the days of the competition, will be arranged by the college.

## 11. Miscellaneous :

- 11.1. The scouting of any type will amount to disqualification of the team from the competition.
- 11.2. Necessary books and reports for reference must be brought by the participants.
- 11.3. No travelling and dearness allowance will be paid to the participants.
- 11.4. The decision of the judges is final in regard to the result of the competition and no complaints in this regard will be entertained.
- 11.5. The Organizing College reserves all the rights to change any of the above rules if so required and as they deem appropriate.

### 2021-2022

# (29th January 2022)

Yashwantrao Chavan Law College, Pune organized a Yashwantrao Chavan National Moot Court Competition Online on 29<sup>th</sup> January 2022. We have been conducting this competition for the last Sixteen years. It is our regular practice to frame the moot problem of the competition based on contemporary legal issues giving exposure to students in practical areas of law.

This competition was inaugurated by Principal, Dr. Shubhada Gholap. In the inaugural session she welcomed the judges and the participants. She also narrated the importance of National Moot Court Competition for college students.

Dr. Ujjawla Sakhalkar, Assistant Professor in New Law College, Bharati Vidhyapeet, Pune presided over the Final Round. At the valedictory session, while passing the remarks about the competition she congratulated the participants for participating in this competition. She stressed the the need of acquisition of the various skills required for advocacy and such participation gives them hands on experience.

This competition was conducted in two rounds. Various academicians of different colleges in Pune helped us by presiding over the first round of this National Moot Court Competition. The first prize of the competition, (Rs.10, 000/- and e-Certificates) was bagged by Smt. Kamalaben Gambhirchand Shah Law School, Matunga, Mumbai. While Symbiosis Law School, Pune secured Second Prize (Rs.7000/-. and e-Certificates). Miss. Tanaya Hirve was declared as the Best Mooter of this Competition with (Rs.3000/- and e-Certificates). Best Memorial Prize (Rs.2000/- and e-Certificates) was secured by Central University of South Bihar.

### Yashwantrao Chavan National Moot Court Competition

### 2021-22

### Moot Court Problem:

The Union of Chalukya is located in the South Asian Region of Asia. It is one of the ancient nations in the world. It is a democratic country with a written Constitution and having 28 States and 8 Union Territories.

The Industrial Revolution had a great impact on human society. The mode of production was deeply affected by the Industrial Revolution. In factories, the production of goods in large quantities began to happen more efficiently. There was a huge increase in wealth. International trade also increased. As a result of industrial revolution, the new economy created a new society. Which logically resulted in changes in the fields of political, ideological, educational, cultural, literary etc.

Labour policy in Union of Chalukya has been evolving in response to specific needs of the situation to suit requirements of planned economic development and social justice and has two-fold objectives, namely maintaining industrial peace and promoting the welfare of labour. The prevailing social and economic conditions have been largely influential in shaping the Chalukya labour legislation, which regulate various aspects of work such as the number of hours of work, wages, social security and facilities provided.

The corona virus disease (COVID-19) pandemic, which originated in the city of Wuhan, China, has quickly spread to various countries, with many cases having been reported worldwide. Since then, there has been a significant rise in the number of COVID-19 patients in Union of Chalukya's various states. Considering the seriousness of the disease, nationwide lockdown (10January 2020 to 05 February 2020) was announced by the prime minister of Union of Chalukya to control the transmission of COVID-19 and due to which many industries, academic institutes, markets, as well as public gatherings were shut down. After the first lockdown, there have been three more lockdown phases in succession,



COVID-19 put an immediate halt to many business activities across the globe, as several countries had shut down their ports, airports and domestic transportation while imposing nationwide lockdowns, leading to a disturbance in business and civil life. The lockdown in Union of Chalukya impacted manufacturing activities across the globe. The Union of Chalukya took special measures to control the spread by imposing one of the longest lockdowns in the world, to cushion the scarce availability of healthcare resources. The enormity of the lockdown affected manufacturing activities and supply chains alike, disrupting the overall economy.

The State of Kalki of Union of Chalukya invoked its powers under Section 5 of the Factories Act, 1948, and issued a notification exempting all factories registered under the Act from obligations mandated under Sections 51, 54, 55, 56 and 66 of the Act from 18th March till 12th October, 2020.

### Notification of State of Kalki:

A nationwide lockdown was declared by the Central Government from 10<sup>th</sup> January 2020 to prevent the spread of the COVID-19 pandemic. Economic activity came to a grinding halt. The lockdown was extended on several occasions, among them for the second time on 12<sup>th</sup>March 2020. On 16<sup>th</sup> March 2020, the Labour and Employment Department of the State of Kalki issued a notification under Section 5 of the Factories Act to exempt all factories registered under the Act "from various provisions relating to weekly hours, daily hours, intervals for rest etc. for adult workers" under Sections51, 54, 55, 56& 66. The stated aim of the notification was to provide "certain relaxations for industrial and commercial activities" from 18<sup>th</sup>March 2020 till 12<sup>th</sup>May 2020. The notification in its relevant part is extracted below:

"...NOW, THEREFORE, in exercise of the powers conferred by Section 5 of the Factories Act, 1948 (LXIII of 1948), the Government of Kalki hereby directs that all the factories registered under the Factories Act, 1948 shall be exempted from various provisions relating to safety of worker, weekly hours, daily hours, intervals for rest etc. of adult workers under section 51, section 54, section 55, section 56 and section 66 with the following conditions from 18<sup>th</sup> March till 12<sup>th</sup> May2020, -

(1) No adult worker shall be allowed or required to work in a factory for more than twelve hours in any day and Seventy-Two hours in any week.



(2) The Periods of work of adult workers in a factory each day shall be so fixed that no period shall exceed six hours and that no worker shall work for more than six hours before he has had an interval of rest at least half an hour.

(3) Wages shall be in a proportion of the existing wages (e.g. If wages for eight hours are 80 Rupees, then proportionate wages for twelve hours will be 120 Rupees)."

(4) The employer shall ensure safety, adequate safeguards in the factory in terms of occupational safety and health, equal opportunities for women workers working in late-night shifts and adequate protection of their dignity, honour, and transportation from exploitation.

On its lapse by the efflux of time, the State government issued another notification on 13<sup>th</sup> May2020. Similar in content, the new notification extended the exemption granted to factories from 18<sup>th</sup> March 2020 till 12<sup>th</sup> May 2020.

The government justifies the action on the ground that industrial employers are faced with financial stringency in the economic downturn resulting from the outbreak of COVID -19. A trade union 'Haq' filed the writ petition in the Supreme Court under Article 32 of the Constitution to challenge the validity of the state's notifications dated 16<sup>th</sup> March 2020 and 13<sup>th</sup> May 2020.

\*The legal system of Union Chalukya is similar to India and the mooters have to frame the issues and make submissions by presuming that the Constitution of India and all other laws applicable in India are applicable to Union of Chalukya.

### Venue and Date:

# Yashwantrao Chavan National Moot Court Competition (2021-2022) will be held Online on 29th January 2022 by A.B.M.S. Parishad's Yashwantrao Chavan Law College, Parvati, Pune -9.

### 1. Eligibility:

- 1.1. All the Colleges / Law Schools are welcome to send only one team comprising of two students to participate in the competition.
- 1.2. All students of three years or five years law courses are eligible for the competition.
- 1.3. The organising college may have a team participating in the competition.

### 2. Team Composition:

- 2.1. Each team shall comprise of two members consisting of two Mooters.
- 2.2. The identity of the College / School should not be disclosed to the judges or to anyone either directly or indirectly, during the conduct of the Competition.

### 3. Platform

3.1. The competition will be held in online mode with platform of Microsoft teams. All the participants should download the app on their desktop/laptop. The participating team has to ensure adequate internet speed at their place at requisite time and dates.

#### 4. Registration of Team:

4.1. The participants should submit registration form at https://forms.gle/pg3xpThBSCB5jLFK6 The participants have to state their side they are representing (as petitioner or respondent)

for the preliminary round in the said form. Each participant has to give mobile number linked with his/her Whatsapp account in the said form.

- 4.2. When a team is selected for the final round then the concerned participant has to argue from opposite side i.e. petitioner in the preliminary round will be respondent in final round and respondent in preliminary round will be petitioner in final round.
- 4.3. The registration for competition can be made by submitting the registration fee of Rs. 1,000/- by Demand Draft of a nationalised bank drawn in favour of Yashwantrao



Chavan Law College, Pune payable at Pune to the following postal address by 15<sup>th</sup> January, 2022 along with the postage of memorials.

The Principal, Yashwantrao Chavan Law College, Parvati Ramana, Pune- 09 (M.S)

- 4.5. Students are also supposed to attach Scanned photo copy of Drawn DD in Google Registration form. So as to avoid inconvenience caused due to Postal delay.
- 4.6. Team participation in the competition will be confirmed only after the receipt of the DD in physical form within the given time limit ie; (15/01/2022).

### 5. Memorials :

- 5.1. All teams must submit two copies (Hard) of the Memorials (for respondent and petitioner each) (total four- 2+2) on the address of the college and a Soft copy of each memorial has to be sent on the email address (mootcourt.yclawpune@gmail.com) in pdf format on or before the 22<sup>nd</sup> January, 2022. In the soft copy, first page describing names of participants, college etc. should be deleted. The file should be named as---- College name\_\_\_\_ petitioner/respondent ex- Memorial Petitioner or Memorial Respondent. Late submission of memorials may attract reduction of marks.
- 5.2. Memorials shall strictly contain following particulars:
  - · Title page
  - · The table of contents,
  - · The index of authorities,
  - · The statement of jurisdiction,
  - · The statement of facts,
  - · The statement of issues,
  - · The summary of pleadings,
  - · The arguments advanced,
  - · The prayer.
- 5.3. The memorial submitted in hard copy should not be of more than 20 pages. The first page *i.e.* page(in hard copy only) after the cover page, on title page the participant should provide the information as to name of the competition, name and address of the participating College / Law School and names and class of individual members of the team.
- 5.4. The information as to name and address of the participating College / Law School and name of member of team should not be disclosed in any manner, whatsoever on any other page, of the Memorial.
- 5.5. Both the mooters of each team shall prepare to argue from both the sides *i.e.* petitioner and respondent.



5.6. The Memorial shall strictly be in the following prescribed form: Principal part:

> Paper size - A4, Font type - Times New Roman, Font size - 12, Spacing - 1.5, and Margin on all sides - 1 inch

#### Footnotes:

Font type - Times New Roman, Font size - 10, and

- Spacing 1
- 4.5 The Memorial must not contain any Annexure, Photographs, Sketches, Exhibits or Affidavit, etc.

## 6. Marking Criteria for Memorials :

- 6.1. The memorials will be assessed by a special panel of two memorial judges. The decision of the memorial judges as to assessment of memorials shall be final.
- 6.2. The memorials for both the sides will be marked on a total of 30 marks each, by two memorial judges separately. Accordingly, the Team Memorial Marks will be the aggregate of the marks given by both the memorial judges to the memorials from both the sides.
- 6.3. The allocation of 30 marks for each memorial shall be made on the basis of the following criteria:

- 7. Orientation of Participants and Drawing of Lots:
  - The competition shall consist of preliminary and final rounds, to be conducted on 29<sup>th</sup> January 2022.
  - All the links will be provided on the Microsoft teams app.
  - All the communications will be made to the participants on their Whatsapp number

## Preliminary round (29th January 2022)

7.1. Orientation programme of the participants will be held at 10.00 am by giving the participants a link on 28<sup>th</sup> January 2022.



- 7.2 The purpose of orientation programme is to make the participants aware about the rules of the competition
- 7.3 Each team will be given number T1, T2, T3..... and Petitioner and respondent in concerned team will be labeled as [P1R1], [P2 R2], [P3 R3]...... The team number and respective participant label will be intimated well in advance before the orientation.
- 7.4 Since the preliminary round is a team event, the concerned petitioner from same team will argue against his team partner who is respondent. Hence there will be no memorial exchange amongst the participants.
- 7.5 The draw will be done impartially at the college level. In preliminary round, the teams will be allocated to courts by drawing chits.
- 7.6 If the team is not present /available on requisite and specified time allotted then its entry will not be considered for the competition.
- 7.7 Language of the competition is English.

## Final round (29th January 2022)

- 7.8 The final round will be conducted on 29<sup>th</sup> January 2022 in online mode and platform will be Microsoft team. The team who secure maximum marks from each court will be selected for final round. The final round is mismatch round. The participants from one team will be given their opponents from other team by following method for forming pair for argument. The participants will be given brief orientation and will be provided link for their session. They will also be intimated their time slot.
- 7.9 After selection of team, from every court, Participants will be matched in this manner

7.10 Detailed list of petitioner and opponents along with their mismatch partner will be intimated individually. The participants will be sent memorial of their concerned opponent by email.

## 8. Conduct of the Preliminary Round:

- 8.1. Preliminary round will be conducted on 29th January 2022 at 10.00 am.
- 8.2. For the preliminary round, there will be 3 Courts established.
- 8.3. Participating team members must maintain the decorum of court and they shall follow the dress code as prescribed by the Bar Council of India under the Advocates Act, 1961.



- 8.4. Each mooter will have a maximum of 15 (12+3) minutes to present his/her oral submission. A maximum of 5 minutes can be reserved for the rejoinder/ sur-rejoinder from the allotted time of 15 minutes. The team has to intimate their allocation of time for submission, rejoinder or sur-rejoinder to the judges at beginning of the arguments.
- 8.5. Three minutes before the completion of the allocated time (for each mooter) there will be a oral intimation, given by court coordinator and at the completion of the allotted time for each mooter, there will be a final intimation, given by court coordinator
- 8.6. The decision of the Court coordinator as to the time structure will be final.
- 8.7. The oral submissions for both sides shall be marked on a total of 100 marks by single judge (50 for each side).
- 8.8. The allocation of 50 marks for each oral submission shall be made on the basis of the following criteria:

- 8.9. The decision of the judge as to assessment of oral submissions shall be final. The participants are required to answer the queries of the judges.
- 8.10. During the preliminary and final rounds participant team cannot use any other electronic devices except those providing access to competition.
- 8.11. The participants are required to put their camera on while presenting their side.
- 8.12. On the basis of the total marks of each individual mooter received in oral submissions at the preliminary round, best mooter certificate shall be given, to the mooter with the highest marks.
- 8.13. On completion of the preliminary round, the total marks of each team shall be computed by adding the oral submissions marks of both the mooters and the memorial marks. Top team from each court shall qualify for the final round.
- 8.14. If there is a tie between two or more teams within the same court, then a team having more memorial marks shall be qualified for the final round.
- 8.15. If the tie again persists, all such teams shall be qualified for the final round.
- 8.16. The qualifying team will be intimated time and link of orientation for final round. As arrangement stated above, one participant will be matched against participant from other team. List of petitioner and opponents will be intimated individually. Each participant



will receive a link from the organizer along with memorial from his opposing participant (by email and Whatsapp) for final round.

### 9. Conduct of Final Round:

- 9.1. In the final round, there shall be mismatch of the Petitioners and Respondents amongst the teams.
- 9.2. If a mooter at preliminary round has submitted his/her oral submissions on behalf of one party, then at the final round hc/she has to submit his/her oral submissions on behalf of the opposite party i.e. the petitioner in the preliminary round will be the respondent in the final round and vice-versa.
- 9.3. The other rules applicable to the preliminary round as to allocation of 50 marks, time schedule, general conduct, etc. shall be applicable *mutatis mutandis* to the final round.
- 9.4. On completion of the final round, the total marks of oral submissions of per participant shall be calculated and the top two teams with the highest total marks shall qualify for the winner and runner up certificates.
- 9.5. If there is a tie between two or all the three teams, memorial marks would be considered for deciding winner and rank in the competition.

## 9 Working of the preliminary round

- 9.1 On 28<sup>th</sup> January 2022 after draw, every participant will get link on the Microsoft teams for preliminary round. The every participant team will be given time slot for the competition.
- 9.2 Before competition begins at stipulated time, the concerned participants will enter into lobby by clicking on the link at least 10 minutes before.
- 9.3 The Pair of participants which will be arguing will be admitted in the courtroom by the court coordinator. Only one pair will be admitted in court at one time.
- 9.4 Participants have to ensure due bandwidth and availability of internet at their end.
- 9.5 If at the prescribed time, if the participants forming pair are not in the lobby at stipulated time then they will not be allowed later to argue/participate. No arguments, regarding nonavailability of the bandwidth or other reasons will be entertained.
- 9.6 No extension of time will be given, if participant joins late.
- 9.7 If one of the member of pair is absent then the he will not be marked and considered as absent.
- 9.8 After argument, the concerned participants (pair) have to sign out from the link. After the same, next pair which will be waiting in lobby will enter the courtroom.
- 9.9 After all the pairs have argued, the result will be calculated and declared on Whatsapp Group of the Participants created by the college. The top team from each court will be eligible for the final round. The participants of team entering in final round will also intimate individually.



## 10 Conduct of the final round

- 10.1 Final round will be conducted on same day that is 29th January 2022 at 02.30 pm.
- 10.2 Each participant will be intimated his opponent and along with the same, he/she will receive memorials from other side by email. The pair will be decided as per the table given above.
- 10.3 The eligible participants for final round will receive separate link stating time slot for final round.
- 10.4 Every participant has to be present in lobby (10 minutes) before stipulated time
- 10.5 The participant pair will be admitted in the courtroom by the court coordinator. Only one pair will be admitted in court at one time.
- 10.6 Participants have to ensure due bandwidth and availability of internet at their end.
- 10.7 If at the prescribed time, if the participants forming pair are not in the lobby at stipulated time then they will not be allowed later to argue. No arguments, regarding non-availability of the bandwidth or other reasons will be entertained.
