### Workshop on Disaster Management

2021-23-

As a part of academic enrichment, the college organizes various academic programs for the students as well as peers. The college has organized a workshop on Disaster Management on 08/04/2022, Friday. The workshop consisted of two sessions dedicated to the importance of disaster Management.

The workshop was inaugurated at the august hands of Prin. Dr. Shubhada Gholap and she made brief Introductory remarks regarding the workshop. Guest was introduced by Prof. Mrs. Shirlekar

In the first session Col. V N Supanekar explained the policy framework and institutional mechanism for Disaster Management. In the beginning he explained various provisions under the Disaster Management Act of 2005.he stressed on importance of vigilance and preparedness which can effectively cope with disasters. He stated that for effective mitigation along with anticipation of risk, plan for its management and some skills are required. The skills can only be acquired through training. He elaborated that there was paradigm shift for regulation of disaster management. All disasters are considered as emergencies and not vice versa. Incidences can be controlled when treated urgently and can prevent disasters. Identification of risks places would prepare for disaster. For disaster management involvement of community is cardinal. The community may put pressure on government. The policy should be prepared not respond.

In the second session Mr Rajkumar, Inspector, 5<sup>th</sup> battalion, NDRF, Sudumbre conducted familiarisation exercise and community awareness program. He along with 7 members of battalion gave demonstrations for coping with disasters which would prepare the persons for emergencies.

Dr. Patil R A and Prof. Chalwadi were coordinators for the workshop. Total 196 students participated in the workshop.

The workshop was inaugurated at the august hands of Prin. Dr. Shubhada Gholap and she made brief Introductory remarks regarding the workshop. Guest was introduced by Prof. Mrs. Shirlekar

In the first session Col. V N Supanekar explained the policy framework and institutional mechanism for Disaster Management. 




