1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Curriculum is essentially the core part of the entire teaching-learning process. Even though the college is affiliated to the University and has restraint on the development of curriculum, it implements the curriculum effectively by following a proper mechanism.

There is enough flexibility in the curriculum by way of choice of electives in each programme-BALLB, LLB and LLM. Out of these three programmes, LLM is based on the Choice Based Credit System.

In addition, the college presently offers 5 different certificate courses to bring in more interdisciplinary areas and skill based learning for the students. The faculty is involved in developing curricula of the courses as well.

To do complete justice to the curriculum and practical papers in it, the college organizes visits to the courts, the jail, police station and various other organizations so that the students can get practical inputs of the system.

The guest lectures are also organized to give the students practical inputs about their professional career. By this way the college makes sure that curriculum is implemented effectively

Teaching-learning and Evaluation

The institution has to execute the admission process as per direction of the Government of Maharashtra and norms BCI and UGC. The admission process and due dates are communicated through government & college website. Institution follows meticulously fee structure & rules and regulations regarding fee concessions, reservation

During process of teaching, the concerned faculty identifies the weak and advanced learner within class, by adopting an internal assessment calendar consisting of case review, Section interpretation. Group discussion or News idem analysis, Quiz. The regular interaction (between faculty and students) and examinations focus on assessing understanding levels of students.

Bridge courses, rubrics and revision lectures help the student the overcome linguistic and academic inadequacies. To cure inadequacies student and faculty mentor is appointed, with mentor mentee ratio. Teaching plans, academic calendar, timetables, diaries maintained by faculties ensure continuous, robust and systematic teaching. For experiential learning various programs like internal moot court, Legal aid camps, Study visits are organised. The participatory learning is facilitated through seminar & workshop, group discussion, competition, National and internal moot court competition.

To enhance experience, the faculty use ICT. The faculty use Microsoft Team platform to conduct lectures & tests for better participation of the students. The students are given list of webpages, websites e-notes for reference and enrichment. The library has OPAC system, adequate e-resources and database for faculty and

students.

Faculties have significant teaching experience and institution promotes and provides infrastructure for faculty to do research. The institution also encourage participation in orientation, refresher courses which assist them for promotion through CAS. The examinations are conducted at college internally and externally. The examination notices are displayed promptly through website, notice board and WhatsApp group created for various classes. The assessment of question paper is done and results are displayed. In case of any grievances the students are extended facility of photocopy, verification, and revaluation and suitable action is taken by CEO.

Reports and classroom interaction helps the faculty to evaluate of the objectives achieved. Also, the achievement of course and program outcomes are reflected through passing percentage of the students.

Research, Innovations and Extension

In the process of teaching-learning and evaluation, the college has taken several steps for the academic enrichments and holistic development of the student and faculty.

The college has received grants from the affiliated University and National Institutes. The College has organised various seminars, conferences and workshops on contemporary socio-legal issues. The college has built an ecosystem for carrying out research for the betterment of the society. This is achieved through state-of-the-art library, connection with the world of academics via internet and e-resources. The consistent efforts in the area of research methodology and IPRs facilitating the students and teachers to lay their hands on dynamisms on legislative and judicial areas which is reflected in various ISSN and ISBN publications. The college runs its research journal named Spiritus Lege and has recently received its own Ph.D. Research Centre.

Along with the academic enrichment, the all-round growth of the students with an object of creating a law abiding citizen, the college has practiced extension activities. To steer pro bono efforts in practicing law amongst student the college practice various extension activities. NSS concentrating on comprehensive growth of the nation receives its volunteers from the college. The work done through this activity has been recognised multiple times. Legal Literacy Camps in the villages of the district Pune is another extension activity of the college to give real life exposure to the students. Students also volunteer with Social Suraksha Organisation, an NGO working with an object of beggar free society. The students' magazine of the college named Yashada has been awarded second prize under the category of professional college category by the University.

The collaborations and linkages of the college with various organisations and upcoming tie-ups are its persistent efforts for betterment of the students.

Infrastructure and Learning Resources

The institute provides for adequate infrastructural facilities to advance the process of teaching-learning which is the soul of education. The institute has an independent new building and old building with 22 classrooms, Moot

Court hall, Seminar hall, Ph.D. Research Center Room, staff rooms and various cells, Principal's Office, administrative office and store-room.

The classrooms are equipped with all traditional state of art furniture facilities as well as modern ICT (projectors, speakers, Wi-Fi along with white/blackboards) facilities. Seminar hall, Common conference hall facility and other spaces of the parent institute is used for the conduct of competitions, other co-curricular and cultural activities. The institute has utilized the funds secured from Savitribai Phule Pune University and UGC for augmentation of infrastructural facilities.

Library, soul of an education institution is efficient and well-equipped with a collection of books, journals, and legal databases-online, offline (Law finder, AIR Judgments and Case laws, N-List) along with a reading hall and computer laboratory. Library is updated, digitized and partially automated and uses the Integrated Library Management System (LIB-MAN, Web OPAC). The Computer Laboratory, an essential facility for undertaking legal research has 20 computers consisting of N computing Server and client computers, and all ICT facilities.

To ensure the effective implementation of this learning centric pedagogy, the college has regularly updated its IT facilities. The Computers in the Computer lab, Library, Staff-room and Administrative Office are on Peer to Peer Local Area Network (LAN).

The institute maintains and fully utilizes the existing infrastructure of academic and physical facilities. Various committees are established by the institute to maintain and utilize physical, academic and IT facilities of the college. The budgetary allocation ensures updating and maintenance of all the equipment and related facilities viz., building, furniture, equipment, computers and other e-learning sources.

Student Support and Progression

Recognising the value of personalised attention, we have created a comprehensive mentoring programme in which each student is paired with a faculty member who serves as their mentor. These mentors offer intellectual and emotional support to students, monitor their progress, and assist them in making informed decisions about their education and career options. We have integrated skill development efforts within our curriculum, in addition to support services and mentoring programmes. We think that a well-rounded education provides students with the skills they need to thrive in their chosen careers. As a result, we are constantly striving to establish a conducive learning atmosphere that fosters their entire development and prepares them for future difficulties.

We are committed to facilitating the smooth progression of our students through various measures. Continuous evaluation, feedback mechanisms, and periodic assessments are employed to monitor their progress. This allows us to identify areas of improvement and provide targeted support to students who may require additional assistance. We also actively encourage students to participate in research projects, internships, and experiential learning opportunities to enhance their practical skills and real-world understanding.

Our college places a high value on diversity and providing support for diverse students. We have taken steps to accommodate students with special needs and those from underserved communities.

Our institution's successes in conducting students-oriented activities demonstrates dedication to student support and advancement. Governance, Leadership and Management

For overall development of the students college conducts various academic and extracurricular activities *viz*. legal literacy camps, visits to courts and the police station, participation of students in Lok Adalats etc.

Starting from management, running through CDC and IQAC and up to the various committees of the teachers there is decentralisation and democratisation of decision making in the college.

College supports its employees through welfare measures and financial support (e.g. Credit Society and other governmental schemes) and also conducts training programmes for them. College conducts Regular audits.

Infrastructure of the college is used in the fullest extent for mobilisation of funds.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The law college is a single discipline college. The New Education Policy 2022 emphases the multidisciplinary approach to education and development of skills. It is yet to be implemented from the university and the state government. Even though the NEP has not been yet implemented, the college focus on interdisciplinary approach. 1. 1.1.1

The Institution ensures effective curriculum delivery through a well planned and documented process

Response:

The college is permanently affiliated to Savitribai Phule Pune University, Pune and implements the syllabi of the Law degree programmes viz, LL.B., B.A.LL.B. and LL.M. prescribed by it from time to time. In order to implement the syllabi of UG and PG courses, the college has a systematic mechanism at different levels.

The academic calendar committee prepares the calendar of the entire academic year which involves scheduling of various activities, events, programmes and examination. The calendar is drawn up on the basis of the university academic calendar. It is brought to the notice of the students in advance by way of induction programme and through the notice board.

For the effective delivery of curricula of these courses, the time table is prepared considering the workload and the faculty with their expertise in specific areas of laws to do justice to the courses and in the interests of students.

The teachers prepare the teaching plans in the beginning of the academic term to have a good idea of how to put in practice the curricula along with other activities during the semesters. The students learning is ensured by adopting traditional, modern and blended pedagogical methods of teaching law which includes lectures, case studies and analysis, discussion and clinical learning experience.

The effective delivery of curriculum and course outcome is ensured through the supplementary role of cocurricular and extension activities scheduled in the academic calendar. The co-curricular activities include the conduct of national and state level seminars, conferences, workshops and competitions such as National Moot Court, Client Counselling, Debate and Elocution Competition based on contemporary burning issues. The academic activities throughout the academic session promote legal learning, communication skills, along with essential analytical, organizing, and reasoning skills among students. The extension activities include visits, legal aid activities and internship programs to further advance advocacy skills.

The academic flexibility is ensured through the elective choices offered in the university curriculum to the students. The students can choose one subject of their choice in each semester.

Moreover, the college offers add-on/certificate courses on Gender Equity, Advocacy Skills, Introduction to Legal Knowledge and English Communication Skills to bridge the gap in learning and to prepare the students for their career. Students are encouraged to gain more knowledge in the emerging areas of law through the SWAYAM portal. The curriculum implementation also ensures inculcation of various life

skills, human values, gender sensitivity, environmental ethics through the organization of various activities.

To fulfill the aim of delivering the curriculum effectively, the college makes infrastructural –physical and ICT facilities available for teaching-learning. The students have open access to the library and its ICT services.

The academic calendar is meant to give an overview of the activities of the year. It is planned for both teaching learning and extension activities to be conducted in the academic year. The academic calendar is prepared in line with the academic calendar of the University.

The academic calendar, being a kind of guideline for carrying out various academic and extension activities, is monitored by the concerned authorities. In consonance with the calendar, the faculty is required to prepare the teaching plans which help in performing the teaching of various courses.

The Academic calendar also includes the points related to the internal and external exam. The dates of the external exams are declared by the University. However, the teachers follow different methods of assessing the performance. The continuous assessment of the students is based on the guidelines of the University. However the teachers can use their methods to assess the performance of the students.

Generally, the teachers prepare their own schedule of assessment methods. The students are informed the entire procedure of teaching learning in advance so that the students should be well prepared to deal with it. Mostly, teachers deploy tests, quizzes, case study, case analysis, group discussion and small presentation sessions to evaluate the progress of students and these teaching activities help the faculty in understanding the preparation of the students.

On the basis of the above methods of assessment, the faculty is able to choose weak and strong learners. The strong learners are required to assist the slow learners to perform better in the forthcoming academic activities.

In addition, the college conducts the mid-term exam as per the schedule prepared by the examination officer of the college. Students are required to write descriptive answers of four/five questions covering the core areas of the courses. This facilitates the idea as to how far the students are prepared to deal with the subject.

The faculty also shares the sample answer sheets with the students to give them the right feedback on their progress and to judge themselves in a better manner.

As per the schedule of the internal assessment, the faculty organizes group discussion, presentations and tutorials as well. Even in some cases the students make written submissions. Various competitions such as essay writing, debate, elocution, moot court, client counselling are also organized to strengthen their skills.

By way of exercising these methods of assessment, the college makes sure that course and programmes outcomes are properly attained by the students. The result analysis of the students is also carried out at the end of the academic year. It is intimated to the management of the college. In all, the academic calendar and the calendar of the internal assessment are beneficial for both the faculty and the students.

1.3 Curriculum Enrichment

1.3.1

Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Constitutional and Human Values, Environment and Sustainabilityetc. into the Curriculum

Response:

Educational institutions play a significant role in contributing to the development of society. Education related to crosscutting issues gets reflected through the overall conduct of the students. The Law programmes contain courses deeply connected to the crosscutting issues about gender, professional ethics, human values, environment and the Constitution.

The third year of five year programme and the first year of three year programme of law, BALLB and LLB, deal with the Constitution, its history and constitutional values that have developed over the years. The Constitutional law (LC 601) covers the areas of gender discrimination, casteism, religion and the others.

Similarly the fourth year BALLB and the second year LLB courses contain the issues of professional ethics and code of conduct for lawyers. The courses of Family Law (LC 0502 and LC0602) also covers the family system in India and its values. The second year BALLB course, Society in India also shed light on family values, social values and gender related issues.

Courses such as Human Rights Law (LO805 and LO807), Vulnerable and Disadvantaged Groups (LO 807) and Humanitarian and Refugee Law (LO1009) deal with the issues of the suppressed, the lower classes and victims of various offences. They impart human values to the students and make them aware of the rights they are conferred with by the Constitution and the other laws.

The students also study Environmental Law (LC 903) through which they are made aware of their responsibility toward clean environment and sustainability. the laws dealing with air, water and soil pollution.

By way of teaching Intellectual Property Rights to the students, the significance of creativity, invention, innovation is also shared with the students. The students are also made aware of the fact how the law protects intellectual property of the people who make extraordinary efforts to create or invent something in the interest of society.

The faculty of the college ensures that they share the positive information about the abovementioned institutional and human values with the students and all possible attempts are made to enlighten them.

2.2 Catering to Student Diversity

2.2.1

The institution assesses the learning levels of the students and organises special Programmes/ have policies in place for different levels of learners

Response:

The college faculty initially assesses the students through response of the students, levels of understanding of the students in class. The concerned teacher separates the slow, medium and advanced learners. The classroom performances, quiz and other techniques are used to determine techniques to be used for continuous improvements. Further each faculty prepares separate assessment calendar for each class based on various techniques to be adopted. Along with teaching the said assessment calendar is meticulously followed which helps the faculty to understand level of understanding.

The students are assessed collectively and individually by adopting techniques like case study, MCQ and discussion of contemporary topics. For Individual assessment quizzes and competition are conducted. The student is assessed for capacity to understand problems, strategy building, and language prowess. He is guided to develop professional aptitude. The student is encouraged to give power-point presentations, participate in the competitions like debate, elocution, Law review etc.

The effort is made improvise drafting skills and professional attitudes. The curriculum as prescribed by the university is meticulously followed and completed. Due effort is made to make student understand practice requirements and application of law to issues brought by the client. The student is instructed to develop analytical perspective during problems faced by the client. Further research capacities are enhanced through training programs..

The internal examinations are taken based on specified syllabus. The institute intends to scrutinize understanding of concepts, principles, doctrines, and standards of legal application. The term end examination is conducted by the university. The question paper is set at the joint meeting of chairman and paper setter at meeting held at university campus. The instruction is given to set question paper considering slow and advanced learners, '

Considering the progress of the student bridge courses are designed. The college makes special English speaking course to develop argumentative capacity and overcome linguistic disabilities. All these assessment and curative methods for slow learners are being part of regular teaching schedule and it helps the students in continuous learning

2.3 Teaching- Learning Process

2.3.1

Student centric methods, such as experiential learning, participative learning peer learning, team teaching, case law method and problem solving methodologies are used for enhancing learning experiences

Response:

Our institute provides for an pedagogical methods of law teaching. To enhance participative learning. The institute organizes various activities like moot court competitions, court visits-labour and industrial court, Lok-dalat visit, Client Counselling Competitions, Youth parliament, and organise various workshops to give hands-on learning experience to students. Students are motivated to participate in intercollegiate and intra-collegiate competitions which boosts confidence in students and promotes communication and presentation skills, argumentative skills and research aptitude in students. Participation in law related various competitions helps students to have practical insights of the legal profession.

The institute focuses on the student-centric methods to enhance the learning skills of students. Faculties make efforts in making the learning activity more interactive by adopting following pedagogical methods.

Case Study Method/ Problem Method along with the traditional lecture method, helps students to enhance the legal logic of students and their ability to apply the gained knowledge of legal principles to the real problems. Problem solving skill is inculcated amongst the students through this method. For e.g., Indian Penal Code, Family Law. The Case method involves the student's participation actively in the learning process.

Case Law Analysis Method, enables students to understand the application of general principles and its exception. The landmark decided cases are discussed to make the students understand the legal issues and the application of law through various interpretations. This method is used in various competitions

viz, Moot Court, Mock Trial, Client Counselling competitions conducted regularly. This method promotes various advocacy skills such as analytical skills, understanding legal principles and the application of legal logic. It also develops the organizing and interviewing skills.

Experiential learning, is deployed through the conduct of various co-curricular and extension activities which enhance the cognitive skills of students. Moot Court Competitions, Internships, Visits- Supreme Court, High Court, District Courts, Jail and Sub-Registrar Office. Lok-adalat visit also impart a good learning experience to students wherein the institute refer student volunteers in the activities conducted by District Legal Services Authorities (DLSA). Every year the institutes organizes legal aid camp at rural places wherein the students participate in providing the consultancy under the guidance of legal practitioners along with deliberation on significant socio-legal issues and problems of villagers. The institute facilitates the students to undertake the internship programs so as to have the experiential learning. The institute provides for diploma and add-on courses such as Diploma in Labour Law and Labour Welfare, Diploma in Taxation Law, Diploma in IPR and autonomous courses in Cyber Law, Taxation, Gender Equity and Advocacy Skills.

The students are involved in the conduct of all these activities and encouraged to have group discussion, raise questions, write research papers and participate in various competitions.

College encourages teachers use ICT tools like Microsoft teams, emails to make learning teaching and learning process fruitful. The college has suitable infrastructure for effective use of ICT.

It has eleven classrooms equipped with overhead projector, computer interface for effective use of ICT. Power point presentations are created to give more clarity of the subjects to the students. Teachers also provide e-notes of their concerned subjects to the students which makes it more user friendly and easily accessible to the aspiring advocates.

The seminar hall is also has the facility to use projector through computer for effective display for discourses and programs. The research room facilitate the PhD students for their purposes.

The Library has adequate databases which include Supreme Court and other court cases. The software are installed in library as Law finder, SCC Online, AIR web-world are provided to all the student free of

cost. For encouraging the students training is provided at the beginning of academic year. Other E-resources are also available to the students for additional and supportive study. Variety of webpages and web sites on different topics are also shared with students. The Database N- List is given access to students and faculty for research and other studies.

Microsoft Teams software is used as a platform to conduct lectures as well as other co-curricular activities such as poster presentation competition, client counselling competition case law presentation, power point presentations with use of screen sharing feature. Exams are conducted in MCQ format especially by taking the Covid 19 pandemic into consideration. Teaching sessions are also taken online by adopting to Microsoft teams platform. Further Microsoft teams is also used for conducting online viva examination. MS Teams also used to maintain the attendance record of the students. Microsoft teams was also used for conducting online seminars on various topics. Various queries regarding assignment submission were also resolved through ICT methods.

All requisite communications are made to students by putting up notices through WhatsApp groups and website. For internal assessment purpose college used the email platform for the submission of assignments. Email ID were provided for different subjects which made it easy to assess the assignments.

The student has to pass the internal assessment of every subject for the grant of the term. The college conducts the internal assessments according to the curriculum prescribed by the University.

For the better conduct of the internal assessment, the college declares the schedule of the same well in advance. This facilitates the students to prepare themselves for the exam and manage their studies for the same. Examination is conducted as per notices and curriculum declared. Classroom arrangement is conductive of smooth conduct of examination under supervision of Examination officer of the college. After the conduct of the examination, the answer sheets are collected and assessed by the concerned

appropriate faculty.

The assessment of answer books is conducted meticulously with strict instruction for adherence of quality. For removing human errors moderation is also provided for the answer sheets. The result is displayed for communication to every stakeholder.

The students are provided copy of with their assessed answer sheets and discussed the difficulties they had faced. This exercise helps them to improve their performance in future. The student is facilitated to go for verification and revaluation of the answer sheets if they are not satisfied with the assessment. In case the student is still dissatisfied the matter is discussed in the grievance redressal committee. The issue is promptly resolved through this venue.

The grievances of the students related to University exams are addressed urgently. The communications with concerned authorities are carried out by examination officer and solutions are devised resolving of those grievances.

The college is committed for the academic enrichment of students and prepare the students for the law profession.

2.5.2

Mechanism to deal with internal examination related grievances is transparent, time- bound and efficient

Response:

At the outset for conduct of internal examinations, the students are given detailed instructions regarding the conduct of the examination, rules, timings and syllabus, by publishing on website as well as WhatsApp groups.

During the covid times, when the students could not give the examination due to internet failure or other reasons, on their intimation the institution took exams again. the institution made an effort that no student was deprived from the examinations.

In case of any grievances, the student is instructed to apply in writing to the Chief examination officer. The grievances are immediately acted on and remedy for the same is provided. The institution had constituted Examination Committee to promulgate examination policy decisions. It also acts as a grievance redressal committee for the examinations. The secretary of the said committee is Chief examination officer (ex officio) who convenes meeting regularly and specially. The grievance related decisions are taken promptly and implemented. The decisions are conveyed to aggrieved party, if any.

The results are also displayed on web sites. In case of grievance, relating to marking especially by human mistakes the attendance sheets are scrutinized to remove the defects.

In case of human errors by faculties in uploading the internal marks, the letters are promptly given to examination Department at university to correct the same. If the examinations are taken at College level due changes in mark lists are made and remitted to students.

Before and after covid internal examinations are conducted, based on assignments and the concerned subject teachers promptly assessed and mark them and intimated the marks to respective students. In case of any defect in assessment the students are given choice of calling for photocopy of the answer sheets and further facility of applying and conducting the re-evaluation and verification of marks is facilitated. The subject teacher gives due guidance to the concerned students with grievances for proper answer and understanding.

In case the student is aggrieved by the assessment he can make an appeal to principal. The Principal directs the student to either COE suitably the decisions taken which is promptly acted on by the examination officer.

3.3 Extension Activities

3.4.1

Extension activities are carried out in the neighborhood community, sensitizing students to social issues, for their holistic development, and impact thereof during the last five years.

Response:

Along with formal education, students need to be given an opportunity to work for their society to understand it in a better way. The college runs the NSS unit to engage in social activities. The extension activities are divided into two parts viz. Regular Activities and Special Camp. There are 150 students registered for Regular Activities out of which 75 students go for the Special Camp. The students of the regular activities have got involved in activities such as cleanliness campaign, plastic free campus, human rights rallies, voters registration camps, Voters registration camps, blood donation camps, tree plantation in the vicinity of the college campus and in Pune and helping Warkaris (Pilgrims) in pilgrimage to Pandharpur. The NSS camps also involve the activities like cleaning the roads of the villages, implementing the projects assigned by the university, organizing rallies and lectures of experts on social issues in the last five years. This leads to creating a sense of social responsibility among the students.

The college runs a legal aid Centre in the college which extends legal advice to the needy people coming to college. In addition, the centre organizes legal aid camps regularly with the aim of access to justice and preparing law students to discharge their social responsibility. All the volunteering and coordination of the Camp is done by the College with the help of the students. Legal literacy camps are organized in slums and various nearby villages of Pune. The college offers free legal advice to the villagers or needy people for the legal issues or problems faced by them. The camps also involve awareness rallies on various socio-legal issues, lectures of students and advocates (mostly alumni) and street plays on various laws relating to the place of the camp.

There is a collaboration of college with the Social Suraksha Organisation, an NGO working for an object of beggars free society. This collaboration is active from 2017-18 till date. The College has entered into MoU with the Organisation. The students of the college are involved with the activities of this NGO such as helping beggars for rehabilitation.

Yashwantrao Chavan Law College building is located in the 67 acres campus of the Parent institute-Akhil Bharatiya Maratha Shikshan Parishad enriched with greenery and endowed with **Vanrai Puraskar**. The institute provides for adequate infrastructural facilities to advance the process of teaching-learning which is the soul of education.

The institute has an independent new building and old building with 22 classrooms, Moot Court hall, Ph.D. Research Center Room, staff rooms and various cells, Principal's Office, administrative office and store-room. The classrooms are equipped with all traditional state of art furniture facilities as well as modern facilities. The classrooms in the new building are equipped with ICT facilities in the classroom like projectors, speakers, Wi-Fi along with white/blackboards. LCD Projectors enables teaching-learning, PPT presentation for faculties and students of UG and PG. Accordingly, laptops are made available for the conduct of these activities. The building is Wi-Fi enabled and the building safety is ensured against fire with the help of a fire extinguisher. Back-up system for power failure is ensured through permanent installations of a generator system of 7.5 kva power and 35 kva power and inverter.

The infrastructural facilities such as classrooms, seminar halls are made available to the government and other statutory bodies for the conduct of competitive and other examinations on holidays which enables the institute to raise funds.

One of the essential facilities for the conduct of cultural and other co-curricular activities and competitions is seminar hall. The hall is equipped with ICT facilities and a seating capacity of 200 is used for the conduct of seminars, workshops and conferences, and competitions. The common conference hall facility of the parent institute with the seating capacity of 200 and the engineering college basement space is also used for the conduct of cultural activities.

The institution also has an efficient and well-equipped library along with a reading hall and computer laboratory. The facilities in the institution are periodically augmented and ensured that the staff and students including the differently abled students have access to the facilities essential for teaching-learning.

The library has a vast collection of books, journals, and legal databases to provide comprehensive information to students and faculty. A library reference section and Ph.D. Research center room has all the important references which includes the Halsbury's Law of England, India, AIR Judgments and Case laws, which enables all the researchers- faculties and students to have an access to primary legal sources and online legal databases. A reading hall facility is also available for students to study in a peaceful environment.

A] Sports Facilities

In the institute's campus of 67 acres the adequate facilities are made available for sports, games (indoor and outdoor) gymnasium, yoga and cultural activities. Every year our institute organizes 'Youth Week'-during which various sports events- individual and Team events, are conducted.

The institution has gymnasium in the basement and is open to the students as per the given slots. It consists of various gym equipment. There are indoor and outdoor grounds for various games and sports in the institute campus.

The grounds are regularly made available to the students for practice. Yoga programs includes organization of yoga workshops and celebration of 'Yoga Day'.

For the overall physical, mental and holistic development of the students, various infrastructural sports facilities have been upgraded in recent years. The college provides for these sports facilities to the students along with the sports equipment's for practice. In the recent years, our students have excelled in State level, University level, sports events such as volleyball, Handball and wrestling. Our college has won various trophies in Sinhagad Karandak, Pinnacle (inter-collegiate law fest- Cricket-Runner-up), 'Kridangan- Khel Mahotsav' organized by ILS Law College, Pune.

B] Cultural Activities

Cultural activities play an important role in overall personality development of students. At the end of every academic year annual social gathering is organized followed by Annual Prize Distribution. Cultural

programs are also organized on various occasions such as Fresher's party. For various cultural activities and programs, the basement space of Anantrao Pawar College of Engineering and Research, Parvati is also used. All the students actively participate in organizing, participating and performing various extracurricular events, competitions and cultural activities. During youth week various cultural activities and competitions viz., Mehendi, Rangoli- Traditional & Poster, Treasure Hunt), Fun-fair and various Days-Traditional, Mis-match, Retro Day, Signature Day are organized. Cultural activities includes the Annual Social Gathering wherein the students give their various performances viz., dancing- folk, classical, hiphop, Bollywood mash-up; singing, instrument playing, drama, one-act play, mimicry, etc. College bears the additional expenditure for stage, sound system, mixing desk, music player, lights

Students from various cultural backgrounds actively participate in cultural activities-organized by the institute on campus as well as other institutes in inter-collegiate colleges. The students are permitted to use the classrooms after regular lectures for rehearsals and practice.

The institute provides an opportunity to all the students by encouraging them to participate in various sports and cultural activities and facilitates participation by funding. 4.2.1

Library is automated using Integrated Library Management System (ILMS)

Response:

The institute has adequate library resources to facilitate the learning resources. The library is considered as an essential part for the students and teachers for reference and research. Over the years the students

have used the facility extensively for self-study.

The library is updated, digitized and partially automated and uses the Integrated Library Management System. In order to provide maximum access to the students, the college has been taking deliberate efforts to use ICT enabled facilities in the library. For that LIB-MAN, Web OPAC has been made available. Bibliographic record is well updated to ease the library accession.

The library gives open access to all the students bearing their identity cards with QR codes. Identity Cards are integrated with the library management system. A Card accession system is maintained by the library staff, which has made it easier for library staff to maintain the records. Library collection includes a special collection of competitive examination books and Braille books.

Till date there are a total 18,293 books. Library resources are not only confined to the books but also include various journals, periodicals, and newspapers of Indian as well as of International publications. Beyond that, photocopies of case laws, question papers, syllabus, reference books etc. are also made available to the students.

To assure effective and optimal use of the library the college has set up a Library Advisory Committee consisting of faculty members which ensure provision of quality knowledge to students via resources of the library. Thus, updating and maintaining the library, recommending essential reading are key concerns of this committee. Annual update of e-resource databases like Supreme Court cases, Criminal Law Journal and High Court Cases, is also focused upon by the committee. A separate register of the students availing e-resources is also maintained.

Special attention is provided to the students coming from marginalized sections of the society. College has availed governmental schemes which prescribes concessional book supply to the students from scheduled castes and scheduled tribes. Under which, out of the mentioned books 1767 books have been purchased. Apart from that, 'Earn and Learn' scheme has been much of a help to students belonging to economically weaker sections. Students working under this scheme help library staff in maintaining the library.

To prevent thefts and damages of the books security deposits and security mesh is provided. Effective efforts are also taken by the college to prevent damage to the old books. Regular Pest controlling, moth balls and regular spraying of insecticides is done for securing the library. Besides that E- Resources are secured by updating antivirus software systems.

4.3 IT Infrastructure

4.3.1

Institution frequently updates its IT facilities including Wi-Fi

Response:

In the past decade ICT has made revolutionary changes in pedagogy. It has made education teaching-learning centric. To ensure the effective implementation of this learning centric pedagogy, the college has regularly updated its IT facilities.

The institute has set up several good IT facilities for teaching-learning in its premises. It has equipped almost a majority of (12 out of 23) of the classrooms with LCD projectors having the latest configuration. The institute has 12 Projectors and 11 Printers. In the last five years the college has

installed 27 computers, making the total number of computers 55 including laptops. Accordingly, the softwares installed have also been updated.

Along with it, the college has installed Wi-Fi on every floor, making it easier for students to access internet facilities and use it for educational purposes. It has largely helped in giving remote access of the library to students, making it easier for them to access E-resources. The Computers in the Computer lab, Library, Staff-room and Administrative Office are on Peer to Peer Local Area Network (LAN).

The college has Mastersoft and Tally softwares which are used for administrative as well as academic purposes which are regularly updated.

All the computers are connected with broadband connectivity. In the last five years Internet bandwidth has been updated from 32 mbps to 100 mbps. Apart from above mentioned software facilities, the college also has been updating hardware facilities to facilitate the learning.

In addition, the college has installed biometric, provides for photocopy machines (3), 32 CCTV and 2 bar codes scanners, which serves to soothe the entire administration and teaching-learning process.

The library is digitized and partially automated with the help of Integrated Library Management System. To optimize the access and use of the Library, ICT enabled facilities in the library have been upgraded. For that LIB-MAN, Web OPAC has been made available. All the beneficiaries of the library can record their entry through the QR code scanner, infusing ICT facilities in managing the library.

The administrative office (AO) makes use of IT viz, Management and Information System (MIS) and cloud based ERP Centralized Campus Management System (CCMS) software named Master soft (Master soft ERP Solutions) from 2017-18. The Software is used in administration and library management and facilitates the student's online registration and examination process. The software smoothens the admission and fees payment process (online/offline), maintenance of the students details (Birthdate, Date of Admission, Caste, scholarship, freeship, EWS, Minority). The software also provides Mobile based OPAC Short Message Service (SMS) 12000/Year which is integrated with all softwares. The software advances the conduct of I B.A. LL.B., and I LL.B. Savitribai Phule Pune University examination.

Furthermore, Annual Maintenance Contracts are also retained by the college to keep the existing IT facilities optimally functional. Updating antivirus is one of its crucial parts.

There are established systems and procedures for maintaining and utilizing physical, academic and support facilities - laboratory, library, sports complex, computers, classrooms etc.

Response:

The institute maintains and fully utilizes the existing infrastructure of academic and physical facilities. Various committees are established by the institute to maintain and utilize physical, academic and IT facilities of the college. An important aspect towards the maintenance and utilization of all the infrastructural facilities is budget. There is a provision in the yearly financial budget of the institute. The budgetary allocation ensures updating and maintenance of all the equipment and related facilities viz., building, furniture, equipment, computers and other e-learning sources. The distinct agencies with standard expertise (contractors and service providers) are hired by the institute for maintaining and providing related services such as software solutions, hardware, photocopy and printer, internet, generator battery backup, telephone, CCTV, Lift, canteen, security and parking, Fire extinguisher, sports facilities- ground The service providers are selected on the basis of quotation and entered into Annual Maintenance Contracts (AMC).

The following are the major committees which ensure the need for update and maintenance required and get the things done. The institute's management, IQAC and CDC plays an important role in monitoring and approving the update and maintenance work.

Apart from this there are unit wise procedures for maintaining and utilizing physical, academic, and support facilities.

ACADEMIC FACILITIES:

Classrooms and Seminar Hall:

Classrooms with ICT facilities are used as per the Time- Table prepared by the respective committee for B.A. LL.B., LL.B., LL.M., and Diploma courses. Classrooms are used accordingly as per the Time Table and also for other co-curricular activities and extracurricular activities in coordination with the different committees.

Seminar hall is used for conducting various academic co-curricular and extracurricular programs such as seminars, conferences, workshops, competitions and cultural activities.

Library:

The College has set up a Library Advisory Committee (Composition- Principal, Librarian, three faculty members and Office Superintendent). The Committee monitors effective and optimal use of library services, recommends purchasing of the new books (text and reference), updating and maintenance of the library. Regular maintenance and cleaning of library facilities and equipment is done to ensure the safety of books along with e-resources. New editions of text and reference books are purchased every year and national and international journals are subscribed.

Book bank facility is made available for SC/ST/OBC and Open Category students, which facilitates the learning process among marginalized students. Cataloguing and shelving of books and other materials is done for proper handling and circulation of library materials, including check-out and return procedures. Regular inventory and the library collection is evaluated to ensure relevance and update. Access to online databases and other electronic resources is given to the students. Reading room, computer lab, reprographic and Print out facilities are major components of the teaching-learning process. Book exhibitions are held on various occasions like Vachan Prerana Din, Marathi Bhasha Din etc. for extending reading habits of students and teachers. Daily footfalls of students and teachers in the library are recorded by user tracking software.

Computers and IT Facilities:

The IT team takes care of regular maintenance and updates to hardware and software. Regular backup and storage of data is done to prevent loss of data. Training sessions for computer users to ensure proper handling and use of equipment are conducted.

SUPPORT FACILITIES:

Cultural, Sports and Gymnasium:

Sports committee maintains equipment and ground facilities. New sports equipment and kits are purchased for the students.

Canteen Facility:

The cafeteria is provided to the students and faculties and the contract is assigned by the parent institute.

Other Units:

CCTV surveillance system is maintained for the safety of the institute.

Solar Panel system is used for reducing electricity bills and becoming energy independent.

Generator Facility: College has additional backup provision and inverter for uninterrupted electric supply with 2 Diesel Generator with capacity of 7.5Kva and 35 kva power.

Campus Supervisor:

Campus supervisor is appointed by the parent institute who takes care of the whole campus and ensures environmental sustainability.

(In the interest and welfare of the common masses). This Society was established to carry forward the educational thoughts of the mass leaders like Shri Shahu Maharaj, Yashwantrao Chavan (former Deputy Prime Minister and the Architect of Modern Maharashtra), Keshavrao Jedhe and Bhausaheb Hire who firmly believed that until and unless the common public is educated, the society will not change and there will not be progress in the lives of the masses.

The mission of the college reflects the motto of the Society and the college is striving in that direction.

The institution enlists a large number of students from the rural background, though it is situated in a metropolitan city like Pune. All students receive equally good treatment from faculty and the administrative staff and it helps to create a good education atmosphere in the premises. The **institution charges the students the lower admission fee among other law colleges.** But it provides students standard legal education with all essential facilities.

The institution attempts to meet the needs of the students by bringing new changes in filed of law into actual classroom teaching. The faculties get updated about new areas of laws and share the knowledge with the students. In addition, the experts are invited to deliver lectures on such areas.

In order to provide free legal aid to the poor and needy people, the college runs a **Legal literacy Centre**. In this centre faculties-in-charge gives free legal aid to the individuals who approaches the college. This centre also organises **Legal Literacy Camp** every year in a slum area of Pune city or a nearby village.

To fill the gap in the curriculum and to impart practical skills, college has running certificate courses *e.g.*, **Online Certificate on Advocacy and Drafting Skills, Diploma in Cyber Law** in collaboration with Asian School of Cyber Law among the others.

To increase the research impetus in the institute, college has started publication of **Journal with ISSN Number** in the year 2019. Till 2023, four issues of this journal have been published. In addition to this, college has started **Ph.D. centre**.

Academic affairs, student welfare, research, library, cultural events and other college-level committees help in implementing management's decisions. One of the activities successfully implemented by the college

One of the elements of perspective plan of the institute was to introduce a new certificate course/s either by the institution or in collaboration of the other institute. This perspective plan was discussed in the meeting of IQAC and it was resolve that a Diploma / Certificate Course or Diploma in Cyber Laws shall be started in collaboration with another institution.

As per the resolution taken in IQAC it was decided to start a Diploma in Cyber Laws in collaboration with Asian School of Cyber Laws. For this course Mr. Rahul Bibave (Assistant Professor) was appointed as faculty-in-charge.

After discussion with the office-bearers of Asian School of Cyber Laws, Pune, an MOU was signed between college and Asian School of Cyber Laws on 24 July 2019.

The first batch of the Diploma in Cyber Laws started in 2019-20.

Till this academic year 2022-23, three batches of Diploma in Cyber Laws have successfully completed and the fourth batch of this Diploma is currently going on.

There are several institutions in the campus. There is an organizational structure in the decision-making process that happens at different levels based on the kinds of matters.

Akhil Bharatiya Maratha Shikshan Parishad is the topmost body of the management of the institution. The General Secretary of the Society looks after the day-to-day administration. In the Society, there is a Council, a Governing Council, Board of trustees and Board of life members.

Local Management Committee: The committee has been established as per the provisions of Maharashtra University Act, 2016. This committee is headed by the Chairman who is a member of the Society. It includes another five members of the Society. There is another member who is an invitee. The principal of the college is Secretary. There are three teachers including a female teacher in the Committee representing the faculty. There is a non-teaching member in the Committee. 6.3 Faculty Empowerment Strategies

6.3.1

The institution has effective welfare measures for teaching and non-teaching staff

Response:

Yashwantrao Chavan Law College, Pune is affiliated law college established under the parent institution Akhil Bharatiya Maratha Shikshan Parishad (A.B.M.S.Parishad) in June 1978. Under parent institute A.B.M.S.Parishad there are many other institutes namely Shri. Shahu Junior and Senior College, Namdevrao Suryavanshi ITI College, Karmveer Bhaurao Hire High school, Anantrao Pawar College of Engineering and Research and Anantrao Pawar College of Architecture.

In the parent Institute A.B.M.S. Parishad there are more than 150 teaching and non-teaching staff working in various institutes. For the welfare of all this teaching and non-teaching staff, to provide financial assistance to them and to meet emergency-like situations, the **Shahu Sevak Co-operative Credit Society** was established in 1978. This Credit Society was registered with the registration number P.N.A./B.N.K.-288 on 11/04/1978. Till 31/04/2022 there were total 120 registered members of the Credit Society.

Every month a specific amount is deducted from salary of all members towards contribution to the society. At the end of every financial year, a meeting is conducted of all the members. In this meeting balance sheet of the Credit Society is placed before the members and issues in respect of it are discussed and resolutions are adopted. After the meeting dividend is given to all the members.

The society provides financial assistance to the members of Credit Society in case of an urgent need or emergency situation. After completion of all the formalities and documentation, Credit Society provides financial assistance to them usually within 24 hours to mitigate their financial problems.

Confidential Report: At the end of every academic year, a confidential report of both teaching and non-teaching staff is sent by the college to the parent institute Akhil Bhartiya Maratha Shikshan Parishad, Pune. This report has a relevance in case of any inquiry or action against the employee.
- **2. Teachers' Feedback:** College obtained a periodical feed-back of students on teachers' performance on various parameters viz. teaching ability, his approach, fairness in evaluation, teaching methods used by the teachers etc. On the basis of this feed-back, individual teachers were given suggestions regarding their weaknesses.
- **3. Performance Based Appraisal System:** Promotion of all the teaching and non-teaching staff is done as per the rules of Maharashtra Government and Directorate of Higher Education.

- **4. Maintaining Academic Diary:** In every academic year, all the teachers maintain their individual diary. All the classes, visits, meetings, extra-curricular activities are recorded in it regularly. These diaries are checked by the principal after every two weeks.
- **5. Felicitation on Teachers' Day Programme:** Every year in the programme conducted on the occasion of Teachers' Day, teachers whose subject-result is more than 90% are felicitated. This boost morale of the concerned teacher and also gives reasons for other to work hard towards securing maximum result.

After obtaining the permission and charging a specific fee, the college allowed to conduct the said examination or any other programme as per the request.

Apart from the above-mentioned activities college mobilised the available funds for purchase of essential facilities such as computers, updating internet connectivity and necessary software for improving teaching-learning methods.

6.5 Internal Quality Assurance System

6.5.1

Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes

Response:

IQAC is one of the crucial cells consisting of the members of the management, the Principal (Chairman), external experts and teachers. It discusses both academic and non-academic issues and takes decisions for further processes. The object of this cell is to formulate the policies for improving the quality/standard of education in the college for the betterment of the students. IQAC was established in the year 2010 and since then it has contributed significantly for institutionalising the quality assurance strategies and processes by giving recommendations from time to time. Following are examples of the same:

Practice 1: Publication of Journal dedicated to research articles:

Since 2019 college is publishing an annual law journal called *Spiritus Lege* with ISSN No. It contained articles by academicians, research scholars and students. In the beginning of every academic year the college publish a call for paper from all the interested faculties, research scholars and students to submit a research paper within a specific time-limit and a specified format. A separate ISSN number 2582-1784 is obtained for *Spiritus Lege* Law Journal in the year 2019. Since April 2023 the college has published 4 issues of *Spiritus Lege*. This initiative undertaken at the behest of IQAC has gone long way in providing impetus to research culture at Yashwantrao Chavan Law College, Pune.

Practice 2: Online Certificate Course in Advocacy and Drafting Skill

As per one of the elements of perspective plan of the college to start a new certificate course/s either by the institution or in collaboration of the other institute, in the meeting of IQAC it was resolved that an Online Certificate Course in Advocacy and Drafting Skills shall be started from academic year 2021- 22.

The objectives of this certificate course are-

- a) To bridge the gap between law in theory and law in practice.
- b) To equip the participants to know the intricacies of law practice and interact with the field while undergoing the course.

This certificate course focuses on imparting not only the theoretical but also the practical aspects of advocacy and drafting skills. The course is designed in such a manner so as to make the students well versed in important aspects of advocacy and drafting skill. The contents of this certificate course include the study of key principles of Civil and Criminal Law, Law of Contract, appreciation of evidence and arguments before the courts, registration process, drafting skills, counselling skills etc.

The faculty for the course included experienced advocates, judges and legal professionals. They brought with them a wealth of practical experience and knowledge, which they shared with the participants in their lectures.

The first batch of this Certificate Course (Academic Year 2021-22) was started on 23 October 2021 and ended on 31 March 2022. Total 55 participants successfully completed the certificate course. Second batch (Academic Year 2022-23) of the certificate course started on 18 February 2023.

The review of teaching-learning process and its implementation at institutional level can be categorised in the following points:

I. Teaching, Learning and Evaluation Related Activities

It provides information regarding lectures, seminars, practicals undertaken by faculty as allocated. Lectures or other teaching duties performed as per the norms given by university and UGC, at times in excess of those norms. Teachers prepare and impart the knowledge as per curriculum.

II. Co-Curricular, Extension and Professional Development Related Activities

It includes student related co-curricular extension and field-based activities. For imparting practical knowledge to the students through co-curricular activities college conduct Police-Station Visit, Jail-Visits, High Court Visit, Study-tour visit including Supreme Court of India, visit to Sub-registrar office, Labour court and Industrial visit.

III. Research and Development

Performance Based Appraisal System (PBAS) helps in identifying the potential area of faculty and staff. The score obtained in the PBAS contributes to the decision about faculty appreciation and relevant for their promotion. College has obtained the permission and started Ph.D. Research Centre.

IV. Introduction of Certificate Courses and Diploma

College has started supplementary certificate as well as diploma courses on its own or in collaboration with the other institutes. Namely, Certificate Course on Advocacy and Drafting Skills, Diploma in Cyber Law, Certificate Course on Gender Development, Certificate Course on Communication Skills and Certificate Course on Introduction to Legal Knowledge for Pre-Law Students.

Following are the two examples of institutional reviews and implementation of teaching learning reform:

Example 1: Publication of Journal dedicated to research articles:

Response:

College provides various facilities for women ensuring gender equity and sensitization. Safety and security measures are undertaken at the institutional and college level. Safety and security of students, teaching and administrative staff, premises and of the campus is taken care by appointing security guards at the entry level and the whole college premises is under the surveillance of Close Circuit Cameras which is monitored by head of the institution from time to time.

College organizes workshops on disaster management which equips them to deal any unforeseen calamities. In the college fire extinguishers are set up at prominent places at every floor. College has also set up a Counselling Center at the basement of the premises, under which college has appointed a professional counselor who conducts personal counselling sessions twice in a month at the center without any charges.

The college has appointed class-wise mentors for academic and career counselling. Students are informed about all the safety and security measures/programs well in advance through notices displayed on college notice boards as well as website of the college.

Under Legal Aid Centre of the college, free legal aid camps are organized in neighboring villages, which helps to create among rural women about their rights, importance of education.

Safety and Security measures undertaken by the College are:

- Well-trained and vigilant security guards stationed across the campus.
- Security checkpoints at all campus entries and exits.
- Extensive surveillance network to ensure safety of the students and staff members.
- The Disciplinary Committee is formed at the college level.
- Night patrolling by security guards
- Anti-Ragging Committee is set up to restrict and to prevent ragging practices at college.
- Separate hostels for girls and boys with dedicated wardens.
- Surprise visits are made by the anti-ragging committee to hostels for restricting any kind of ragging practices.
- College has separate common rooms for boys and girls.
- Internal Complaint Committee -ICC has been formed as per the mandate of the **Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013**.
- The boards indicating the constitution of ICC, definition of sexual harassment, punishments and help line numbers are displayed in front of the ladies common room.

The Akhil Bharatiya Maratha Shikshan Parishad (ABMSP) has been running its activities in the campus of 67 acres of land. The institution has taken various initiatives to keep the campus environment friendly. The institution regularly conducts the green-audit of the campus through Green Water Solutions Provider Pvt. Ltd., Pune.

Yashwantrao Chavan Law College, Pune, came into existence in 1978, with the objective to impart legal education. As a part of the fundamental duty of the every citizen college has realised the importance of Holistic Waste Management approach which is essential in reducing its environmental footprint and providing a safe and healthy work environment for teaching and non-teaching employees, students, and visitors.

The College adopts the principles of the 'Best Practicable Environmental Option' in the delivery of its waste management services. The Institute and there by College applies to Reduce, Reuse, Recycle and Recover waste products in preference to the disposal of waste to landfill.

Maximise reuse and recycling where possible. The College requires all the teaching and non-teaching staff, students, guests and anyone else making use of the premises to comply with this Policy to ensure compliance with all waste legislations.

Any solid Wet and Dry waste generated in the campus is managed and handled in accordance with the compliance criteria and the procedure laid down by Municipal Corporation.

The Institution has its own degradable and non-degradable waste management system under which waste is segregated into three parts:

1. Solid Waste 2. Liquid Waste 3. E-Waste Management

Solid Waste:

The waste is generated by all sorts of routine activities carried out in the College that includes paper, plastics, glass, metals, foods, etc. The waste is segregated and collected at designated time intervals. The garbage is collected and compiled in the dustbins (Green and white) provided at each floor. The floor dustbins are emptied in movable containers/dustbins provided for each block and is taken to the dumping yard provided by the College. The College uses shredding machines for the reuse of paper waste generated in the office.

Liquid Waste:

Liquid waste generated is managed by the sewage waste system in the campus

All the solid and liquid waste in collected by PMC's waste collection vehicle from the campus. The institution also has mechanism for the creation of vermi-compost from bio-degradable waste in the campus.

E-Waste Management:

The institution ensures that all the E-waste generated by electronic equipment such as, compact discs, cartridges computers, phones, printers, and photocopy machines are recycled properly. The e-waste generated from hardware which cannot be reused or recycled is being disposed of through government authorized vendors. The college regularly hires the services of Agasti Computers for its e-waste management.

Response:

Best Practice -I

Title of the Practice: - Free Legal Literacy and Awareness Camps

1. Objectives:

Yashwantrao Chavan Law College, Pune has established Legal Aid Centre with the motive to impart Clinical Legal Education and social-legal services to the needy and poor people of the community. It is necessary to expose law students to the practical aspects of the legal field as study of law is a professional course. To fulfil below mentioned objectives Y.C Law College is running Legal Aid Center since last 25 years.

Legal Literacy Camps are also conducted as a part of NSS program during special camps conducted at villages every year

- 1. To Conduct Legal Aid and Literacy Camps in rural and urban areas.
- 2. To provide legal aid and assistance to the poor, illiterate and needy people.
- 3. To provide access to justice by ensuring equality before the law, the right to counsel and the right to a fair trial.
- 4. To create Legal Awareness among general public.
- 5. To ensure the rights of poor and weaker people.

- 6.To provide the existing students with first hand exposure to advocacy and skills of legal profession like interaction with clients, drafting, conveyance and preparation of petitions, applications and litigations.
- 7. To provide legal platform to alumni by imparting their legal knowledge for laymen those who are reluctant to approach to the court.
- 8. To fulfil duty towards society.

The Context

Most people prefer to resolve matters locally and amicably where possible. There is a serious lack of basic legal advice and assistance to guide people in their immediate choices and enable them to navigate the justice system. This is particularly evident at the following levels:

- In villages: there is a general lack of confidence in 'western-style justice'. Access to justice should not only encompass formal justice systems, but also a dispute resolution forum based on restorative justice if preferred.
- At the police station: the risk of intimidation and physical ill-treatment is greatest in the immediate period following the deprivation of a person's liberty. Access to a lawyer or a paralegal is a fundamental safeguard against mistreatment during this time.
- At court: legal aid is usually granted by a judge or magistrate and there are often significant delays in granting assistance, for example, if it is believed that the accused does not have the means to pay for a lawyer.
- In prisons: many of the people who are detained in prisons do not have access to legal advice or assistance and it may take many years before their cases come to trial.

Practice

Legal aid has traditionally been associated with lawyer-centered services. However, the services that the majority of people require are often quite different. Good practice of free legal Aid should focus on the needs of people at the beginning of the criminal justice system. The need of free legal aid is felt more in villages especially among vulnerable section of the community. Said practices can prevent unnecessary expenditure, time-wasting and further the cause of justice – without necessarily having recourse to a lawyer. The right to free legal assistance is enshrined in Indian Constitution under Art 21, Article 39(A) of Directive Principles of State Policy and under the Legal Services Authorities Act, 1987 too.

College organizes Free Legal Aid Camps every year to adjacent villages near Pune City. The Legal Literacy Camp is organized by the College in collaboration with Board of Students' Development of Savitribai Phule Pune University. From the college a common mode of transportation - a special bus is arranged for the participants of the Camp. The Camp starts with a rally through the village with various socio-legal placards and slogans. The slogans and placards comprised of messages on environment protection, cleanliness, gender equality, human rights and education. The students also performs a street play on women rights. The villagers appreciated the street play with their promising response. Students of the college gives informative speeches on various socio-legal issues like RTI, Consumer Protection, Land Revenue Record, various Protective Rights of Women etc. Alumni of the college staying nearby area of the camp site offers their legal aid services, advice and consultancy free of cost to the villagers. This camps are graced by the presence of the dignitaries of the said village. Guests of the camp delivers speech and normally the stress on the need of eradication of evil practices of female feticide and infanticide and educating girl child is highlighted in these camps. Camp is concluded by the interactive

session wherein questions on various legal issues are raised by the audience and satisfactory answers are given by the advocates. Legal aid to the Camp is coordinated by the prof in charge.

Handbooks of Literacy topics are distributed among villagers free of cost

Our literacy topics cover a wide ambit of social laws and aim at educating people regarding their basic and fundamental rights. Some of the topics are:

Domestic Violence Act, 2005, PCPNDT Act ,Noise Pollution Rules, Dowry Prohibition Act, 2005, Sexual Harassment at Workplace Act, 2012, Testamentary and Intestate Succession, Land Laws (Maharashtra) ,Senior Citizens Act, Laws relating to Drugs and Narcotics, Right to Information ,Child Rights, Criminal Procedure Code, Rights of Persons with Disability, Consumer Protection Laws, Jat Panchayat Act, Anti-Superstition and Black Magic Prevention Act etc.

• Evidence of Success:

Local Villagers get free legal aid services at door steps.

Sarpanch, Gram sevaks along with senior dignitaries and villagers in the village found to be satisfied with this Legal Literacy Camps.

Demands to organize in future again.

Positive reports of Feedback Forms gives encouragement for future programs.

Interactive sessions with the practicing advocates helps in clarifying their legal rights.

Students get hands on experience of legal consultancy.

Legal Survey helps the local people to understand various government schemes.

Organization of Legal Literacy Camps are found beneficial for Students, Alumni and Local Villagers.

Alumni of the college staying nearby area of the camp site offers their legal aid services, advice and consultancy free of cost to the villagers which is found beneficially in Long run.

• Problems encountered while organizing the Camps:

Ignorance of law is no excuse. Therefore legal literacy is always a need. The legal literacy camp is one of the solutions to achieve the legal literacy. The law colleges being the torch bearers of the law education, has one of its duties to spread legal literacy. The college organized the legal literacy camps towards that responsibility of social commitment of the college to the villages in adjacent tehsils.

While discharging this responsibility, there are many challenges to be met and hurdles to be overcome. The commutation is the first problems to be faced while organization of the camp. The college arranges a common commutation facility by availing a bus service for the same. The cooperation from the local self-governance authorities and villagers is a must requirement. To face this problem, the alumni of the college, who are residents of the tehsils come for the rescue. Another major problem

faced is of the day and time to conduct the camp. It is the common practice in many villages is that the preliterate class leaves the village early in the morning and returns late in the evening. This leads the campaigners to have the old aged, women and children as the audience of the camp. To overcome this problem the college has to arrange the camp with prior visit to the village and the discussion with the young circles and other associations active in the village.

Mainly **Money**, **Time** and **Long Distance of the Camp Site** are the major problems. However the college tries to overcome these problems with above passible majors.

• Resources Required for the Camp:

To list the resources required for the camp starts and end with human resource. The human resource at the preparation of the camp are available from the college in the form of faculties in-charge working under the able guidance of the principal of the college. The human resource at the end are the villagers for literacy of whom the camp is organized. The next resource required is of commutation. Where having a common commutation facility is must. The public address system for both the lectures and rally is the next resource required. The venue for the conduct of lectures and addressing the villagers is a major resource required. The venue must be accessible and a public place too. All these resources are managed by the college with prior discussions with the elderly persons from the village.

1] 2017-2018:

In academic year Camp was organised on Saturday, 10th February 2018 at village Kutwalwadi – Borkarwadi, taluka, Baramati, district Pune.

Sixty students and two assistant professors namely Rahul Bibave and Manoj Wanare has participated in the Camp.

2] 2018-2019

In academic year Camp was organised on 23th February 2019, in the village khanawadi of taluka Purandar of district Pune.

3] 2019-2020

In academic year Camp was organised on 22nd February 2020 at village Javalarjun, Taluka Purandar, District Pune.

4] 2020-2021

Due to Pandemic of Covid-19 College was unable to conduct Legal Aid Camps in furtherance of social distancing measures issued Government in the year.

Best Practice II: Yashwantrao Chavan Law Lecture series

1. Title of the Practice: Yashwantrao Chavan Law Lecture Series

2. Objectives of the Practice:

- -To provide practical knowledge to the students along with theoretical information.
- -To provide opportunities to the students to interact with the experts from outside and to contribute to the method of independent learning

3.The Context:

It is a part of legal education and curriculum and a statement in the mission of the college that theoretical and practical knowledge should be integrated in the teaching learning process. The series has been started with the intention that students should get interactive exposure to the expertise available outside. In order to achieve the goal, the institution has ensured that eminent people from the field of law and other related fields are invited in this series. Therefore it generally invites judges, experienced lawyers, senior faculties from other law institutions and social activists.

The institution has also aimed that the faculties get involved in the series and exchange ideas and expertise with these external experts and use this knowledge in their day-to-day teaching.

4. The Practice:

This Law Lecture series has been named after Yashwantrao Chavan who was a law graduate and was an architect of modern Maharashtra and who is considered to be an inspiration for every one studying in the institution. This series is organized every year without exception and a minimum of five lectures/speeches/presentations are delivered. It is also specifically meant for interaction with students and teachers. Students get huge practical exposure to this kind of expertise. Two faculty members are in charge of the committee looking after this series.

Generally judges, senior lawyers dealing with various matters in the district courts and the High Court, Associate Professors and Professors, social activists are invited to be part of this series. Sometimes the alumni help the institution to get the proper authorities in particular subjects from the courts to deliver lectures. The lectures are generally decided by the committee on the basis of the subjects being taught in that semester. These guests are paid remuneration as per the rules and the present circumstances. The committee organizes lectures or presentations prominently on the subjects of legal practice like Criminal Procedure Code, Civil Procedure Code, Evidence Law, Constitutional Law, Maharashtra Ownership of Flats Act, Maharashtra Land Revenue Code, Specific Relief Act, Transfer of Property Act, Prevention of Domestic Violence Act, Land Laws, RERA, Professional Ethics, Cyber Crimes, Cyber Laws, Research Methodology, Uniform Civil Code, Art of Advocacy, Significance of Sketches in identification of Criminals etc. In addition, the lectures of ethics of legal practice and life are also covered in the lecture series in order to ensure the overall development of the students.

5. Evidence of Success:

• Guest lectures under the Law Lecture Series are conducted on the subjects which may not be the

part of the regular curriculum. Like Benami Transaction Act, Understanding Practice and Procedure under C.P.C, Practical problems faced by the police machinery during Police Investigation etc. Students get to know the subjects which are not part of the syllabus.

- Guest lectures under the Law Lecture Series helps to fill the curriculum gaps eg: Lectures on Police investigation gives intricacies of procedure followed by the enforcement authorities during investigations.
- Due to the additional knowledge through Guest lectures under the Law Lecture Series, students become more confident which helps them to explore more areas of laws.
- Guest lectures under the Law Lecture Series helps the students in developing skills of advocacy required them in their future life.
- Guest lectures of the Eminent Practicing Advocates under the Law Lecture Series helps the students to bridge the gap between theory and practice.
- Guest lectures under the Law Lecture Series Students helps students to develop holistic understanding of Discipline of Law.
- Students get opportunity to interact with the eminent speakers.
- Some students get the opportunity to work with senior advocates for internship.
- Online guest lectures during pandemic of Covid-19 found to be very beneficial to the students.

6: Problems Encountered and Resources Required:

- College finds difficulty in getting Practicing Advocates on working days during college timings.
- College has to raise funds to organize these lecture on its own.
- Highly experienced and knowledgeable speakers are reluctant to accept invitation of the lecture due to low paid honorarium.
- Students do not get reference or reading material after the lectures.
- Due to the inadequacy of seating capacity these lectures cannot be conducted for the students of all the classes.

College encourages students who have performed well in the national and international competitions by providing travelling allowances, registration fees and exemption in attending classes.
